Alarming Increase of Al-Shabaab and Extremist Activity in Las'anod, Somaliland Raises Concerns



The government has expressed great concerns in the gravity of the issue in the presser whose full excerpt of the press release reads as follow:-

The Government of the Republic of Somaliland Security Forces have confirmed that approximately 600 insurgents led by Fuad Mohamed Qalaf (Shangole) one of the leaders of the Al-Shabaab have entered Las'anod, Somaliland in the last couple of days, this has sparked growing concerns among authorities and citizens. Sources have shared that the objective of the visit by Shangole is to train the local militants on how to prepare explosives and how Al-Shabaab can create a base in the mountains of Erigavo, Sanaag.

In the past few months, Las'anod has witnessed a disturbing increase in attacks, recruitment efforts, and

the spread of extremist propaganda. These activities undermine the efforts made by the government and security forces to maintain law and order in the area. The rise in violent incidents and extremist ideologies poses a significant threat to the peace and stability of Somaliland and the region as whole.

Government denies the news spread by Somalia about the country's universities

The National Commission for Higher Education has declared that there is nothing in the news that the Universities of the country have participated in a conference in Mogadishu, Somalia.

Some Somali media reported on Wednesday that the universities of Amoud, Hargeisa and Burao participated in a conference on higher education in Somalia. However, the Higher Education Commission of Somaliland has denied the claims on the reports. The chairman of the National Commission for Higher Education, Prof Suleiman Dirir Abdi, who reported to Dawan newspaper, said that the news related to the participation of the country's universities in the Somalia conference is not true.

"The universities of Ammud, Hargeisa and Burao are Somaliland, and they are not part of the meetings and affairs of Somalia. The news about the participation in the meeting in Mogadishu is false." The statement of the chairman of the commission thus dispels the rumours and the doubts raised by some of the community about the news spread by some Somali media over the week.

Over five thousand temporary teachers to undergo proficiency exams

The Ministry of Education and Science and the Public Service Organization jointly announced that 5,221 temporary teachers will undertake proficiency exams with the aim of absorbing the best 600 as permanent staffers.

Of the 5221 employees who will take the exams, 4,859 are to remain teachers whereby the remaining 362 will be the employees within the

ministry.

The Chairman of the Civil Service Commission Mr. Khalid Jama Qodax, spoke about the requirements and procedures for the recruitment of public school teachers and educational staff, and urged them to complete all the requirements related to entering the exam.

The Minister of Education Hon.

Ahmed Mohamed Diriye (Toorno), said that the workers were on temporary basis, and noted that they will be distributed to the districts. The minister stood firm that educational centers and places cannot hire temporary workers, and said that the decree issued by the President of Somaliland will be implemented in absorbing all workers.



Governor of Sahil Mr.Ali Abdi Abdillahi received donations of livestock from the people of Laasadacawo district. The livestock donations was intended for the soldiers at the front line stationed in Oog town.

US offers \$10mn bounty for leads on al-Shabaab leader Ahmed Diriye



The United States government has issued a bounty of up to 10 million dollars for information on the whereabouts of Ahmed Dirive, also known as Ahmed Umar and Abu Ubaidah, a high-ranking member of the Somalia-based Al-Qaeda linked militant group Al-Shabaab.

The State Department Rewards for Justice Program issued the notice saying in a statement that Abu Ubaidah currently serves as the leader of al-Shabaab, a position he assumed following the death of the former Al-Shabaab leader, Ahmed Abdi Godane.

Abu Ubaidah was part of Godane's inner circle at the time of Godane's death.

The US has linked the Al-Shabaab leader to attacks in the East African region including Kenya.

"Under his leadership, AS terrorists have conducted attacks in Somalia, Kenya, Uganda, and Djibouti that have resulted in the death of hundreds of individuals," the US State Department said on Thursday. Prior to replacing Godane, the US said, Abu Ubaidah served in several positions within al-Shabaab, including as Godane's assistant, the deputy governor of the Lower Juba region of Somalia in 2008, and al-Shabaab's governor of the Bay and Bakool regions of Somalia in 2009.

Taming al-Shabaab's growth By 2013, he was a senior adviser to Godane, and served in al-Shabaab's "Interior Department," where he oversaw the group's domestic activity.

He shares Godane's vision for al-Shabaab's terrorist attacks in Somalia as an element of AL-Qaeda's greater global aspirations. On April 21, 2015, the U.S. Department of State designated Abu Ubaidah as a Specially Designated Global Terrorist pursuant to Executive Order 13224, as amended.

"As a result of this designation, among other consequences, all property and interests in property of Abu Ubaidah that are subject to U.S. jurisdiction are blocked, and U.S. persons are generally prohibited from engaging in any transactions with Abu Ubaidah," the US said.

The Department of State designated al-Shabaab as a Foreign Terrorist Organization (FTO) and Specially Designated Global Terrorist in March 2008.

In April 2010, the UN Security Council's Somalia Sanctions Committee added al-Shabaab to the 1844 Sanctions List by pursuant to paragraph 8 of resolution 1844 (2008).

Morocco earthquake: 296 killed as buildings damaged



A strong earthquake of magnitude 6.8 has struck central Morocco, killing at least 296 people, the country's interior ministry says.

The epicentre was in the High Atlas Mountains, 71km (44 miles) southwest of Marrakesh, at a depth of 18.5km, the US Geological Survey said.

The quake struck at 23:11 local time (22:11 GMT). There was a 4.9 aftershock 19 minutes later.

People died in Marrakesh and several areas to the south, the ministry said.

"According to a provisional report, the earthquake killed 296 people in the provinces and municipalities of al-Haouz, Marrakesh, Ouarzazate, Azilal, Chichaoua and Taroudant," the statement said, adding that 153 people were injured and hospitalised.

Unverified video clips on X (formerly Twitter) show damaged buildings, other buildings shaking and rubblestrewn streets. People are seen fleeing in alarm and some walking through clouds of dust.

Some buildings in Marrakesh's old city have collapsed, one resident told the Reuters news agency. Several clips on X show buildings crashing down, but the BBC has not identified where they were.

Locals are said to have decided to stay outside their homes in case the city is rocked by powerful aftershocks.

Another man in the historic city described feeling a "violent tremor" and seeing "buildings moving".

"People were all in shock and panic. The children were crying and the parents were distraught," Abdelhak El Amrani told the AFP agency.

He said power and phone lines were down for 10 minutes.

AFP also reported that one family was trapped in the collapsed rubble of a house - and that a number of people in Marrakesh were taken to hospital.

The quake's epicentre in a remote area of the High Atlas Mountains was relatively shallow - and tremors were also reportedly felt in the capital Rabat, some 350km away, as well as Casablanca and Essaouira.

Simple buildings in mountain villages near the epicentre may not have survived and, being remote, it may take some time to determine casualties there.

Radio Ergo Weekly Feedback Report, Issued: 8 Sep 2023

Brief Summary

There was an increase in the number of callers complaining about drought and water shortage this week (31 August-3 September 2023) as compared to the previous week, especially from central regions of the country. As previously, callers in some areas also reported rainfall which created an overall mixed picture. A few callers noted the disruption caused by conflict on lives and livelihoods. Two callers spoke of an outbreak of flu in their areas. The farming and livestock programmes were popular with callers seeking advice and intervention. The following summarises the calls by theme. Drought and water shortage - in Somaliland, a handful of callers in Togdher, Sanag, Sool, and Hargeisa complained of water scarcity and lack of rainfall. A female caller in Togdher said their farms had suffered a setback, and another said their livestock had no fodder or water. A caller in Taleh said the drought was being exacerbated by months of conflict that had displaced people. In Puntland, callers in Karkar, Garowe, and elsewhere complained of lack of rainfall and water scarcity. One said their livestock had no water and they needed aid; another said the Puntland government and aid agencies should help people who





were suffering. In Mudug, callers in Bandiradley, Galkayo, and Harardhere said they were doing alright but waiting for rain. Several callers in Hiran said the rain had stopped and the land was dry. One said they had no water or fodder and needed water aid. In the south, callers in Kismayo and Balad said they had had inadequate rainfall. A caller in Burhakaba, Bay, said they faced food and water shortage due to drought, and a caller in Gedo said they needed aid because of drought. Protection – a caller in Bardera, Gedo, said food was scarce as the area was cut off and prices were high. He added that some people were moving to Al- Shabab controlled areas despite warnings by the government and other pressures. A caller in Dinsor, Bay, said their area was blockaded and transport was not coming in or going out. A caller displaced by the conflict in Lasanod to el-Afweyn said they needed aid.

Health - a caller in Galkayo reported widespread flu in the area. Another caller in Kismayo also reported widespread flu saying it was causing breathing problems in those who were sick.

Education - a caller in Garowe said they had no free schools and the government should provide education services.

U.S. denies role in Somali army drone attack causing civilian casualties

Moqadishu (HOL) - At least seven civilians, including a grandmother and five children, were killed in a drone strike in central Somalia on Thursday after militants sought refuge in a house compound containing a family, according to local elders. The Somali Ministry of Information has confirmed that five al-Shabab members, including three leaders, were killed in a joint operation in the west El-lahelay in the Galgadud region. Among those killed were Olol Ali Guled, who served as the head of al-Shabaab's insurgent militia in Galmudug, Shuuke Ali Dheeg, and Isse Barre, and two other wanted al-Shabab members. Although the government did not specify which international partner supported the attack. The U.S. military's Africa Command (AFRICOM) issued a statement on Friday confirming that Somali national forces conducted a counter-terrorism operation near

El-Lahelay, killing three al Shabab leaders.


The AFRICOM, which has been helping the Somali government in its yearlong offensive against al-Shabaab, acknowledged the loss of civilian lives but did not specify the exact number.

"Unfortunately, civilians were injured and killed in the vicinity of the operation," AFRICOM said in a statement. "U.S. forces were not onsite for the operation and did not conduct air strikes during or in support of the operation." Speaking to BBC Somali, Somalia's deputy information minister, Abdirahman Yusuf, denied responsibility for the civilian casualties. He asserted, "[Al-Shabab] placed explosive devices in a civilian house, which caused the deaths of innocent people." Al-Shabab has been fighting since 2006 to topple the country's central government and install its own rule, based on a strict interpretation of Islam.

Flood prevention – a caller in Buleburte, Hiran, said every time they worked hard to grow crops their farms were destroyed by floods. He wanted advice on how to stop this from occurring. Another Buleburte caller was thankful they were recovering after the last floods had receded.

Agriculture - farmers in Jowhar and Baidoa wanted help with seeds and farm inputs. A caller in Hinlabi, Mudug, said they had their seeds ready to plant and were awaiting the rain. A caller in Sahawanag said their fields looked burned and crops had failed.

Scientists grow whole model of human embryo, without sperm or egg



Scientists have grown an entity that closely resembles an early human embryo, without using sperm, eggs or a womb.

The Weizmann Institute team say their "embryo model", made using stem cells, looks like a textbook example of a real 14-day-old embryo.

It even released hormones that turned a pregnancy test positive in the lab.

The ambition for embryo models is to provide an ethical way of understanding the earliest moments of our lives.

The first weeks after a sperm fertilises an egg is a period of dramatic change - from a collection of indistinct cells to something that eventually becomes recognisable on a baby scan.

This crucial time is a major source of miscarriage and birth defects but poorly understood.

"It's a black box and that's not a cliche - our knowledge is very limited," Prof Jacob Hanna, from the Weizmann Institute of Science, tells me.

Starting material

Embryo research is legally, ethically and technically fraught. But there is now a rapidly developing field natural embryo mimicking development.

This research, published in the journal Nature, is described by the Israeli team as the first "complete" embryo model for mimicking all the key structures that emerge in the early embryo.

"This is really a textbook image of a human day-14 embryo," Prof Hanna savs, which "hasn't been done

an amazing phenomenon." The embryo models were allowed to grow and develop until they were comparable to an embryo 14 days after fertilisation. In many countries, this is the legal cut-off for normal embryo research.

Despite the late-night video call, I can hear the passion as Prof Hanna gives me a 3D tour of the "exquisitely fine architecture" of the embryo model.

I can see the trophoblast, which would normally become the placenta, enveloping the embryo. And it includes the cavities - called lacuna - that fill with the mother's blood to transfer nutrients to the baby. There is a yolk sac, which has some of the roles of the liver and kidneys, and a bilaminar embryonic disc one of the key hallmarks of this stage of embryo development.

'Making sense'


The hope is embryo models can help scientists explain how different types of cell emerge, witness the earliest steps in building the body's organs or understand inherited or genetic diseases.

Already, this study shows other parts of the embryo will not form unless the early placenta cells can surround it.


There is even talk of improving in vitro fertilisation (IVF) success rates by helping to understand why some embryos fail or using the models to test whether medicines are safe during pregnancy.

New Covid variant BA.2.86 behind Norfolk care home outbreak



A new Covid variant is spreading in England and is behind an outbreak at a care home in Norfolk, health officials say.

There have been 34 confirmed cases of BA.2.86, with 28 of those at the care home. There have been no deaths.

It is too early to draw conclusions on whether it is more serious than past variants, the UK Health Security Agency (UKHSA) said.

People eligible for a booster jab this autumn are encouraged to come forward.

The government recently announced that the vaccine rollout would be earlier than planned because of the new variant. It will start next week

The UK Health Security Agency's latest briefing on Covid includes an analysis on BA.2.86, an Omicron spin-off.

It says out of the 34 cases confirmed through sequencing in a lab, five people have needed hospital treatment.

Based on detection of multiple unlinked cases in different regions of the UK, it's likely there is "established community transmission of BA.2.86", UKHSA says.

number of countries around the world.

Dr Renu Bindra, incident director at UKHSA, said BA.2.86 had a significant number of mutations compared to other Covid variants circulating at the moment.

But she added: "The data so far is too limited to draw firm conclusions about the impact this will have on the transmissibility, severity or immune escape properties of the virus."

Dr Bindra said it was likely to be some time before a confident assessment on that could be made. "It is clear that there is some degree widespread community of transmission, both in the UK and globally, and we are working to ascertain the full extent of this," she said.

Changing dates criticised

The Department of Health and Social Care has been criticised for changing its mind on the start date of the autumn Covid and flu vaccine programme.

It usually begins in early September, but was pushed back to October to increase protection in December and January when flu and Covid are more likely to cause problems.

The timing has now changed again, to 11 September, because of concerns over the new variant. Pharmacists said last week that they had been left with very little time to prepare for the rollout of Covid and flu vaccines.

Instead of a sperm and egg, the starting material was naive stem cells which were reprogrammed to gain the potential to become any type of tissue in the body.



3.2.7. Tax Tribunal (Dispute Resolution)

As normally occurs, taxpayers can sometimes can complain the Ministry of finance's tax assessment and collection. In Somaliland, this process is protected in the legal framework. Therefore, according to the Somaliland revenue act, 72/2016, a Tax Tribunal

Commission (TTC) is established. The TTC operates in an independent, accessible, and efficient review mechanisms safeguard a taxpayer's right to challenge a tax assessment and receive a fair hearing in a timely manner. The taxpayers can dispute:

(i) The accuracy of the facts used by the auditor,

(ii) The correctness of interpretation of the tax law, and (iii) The penalties imposed by MOFD.

MOFD has adopted a tiered review mechanism, starting with submission to the internal Objections and Appeals Unit (OAU) for an administrative review. Where a taxpayer is dissatisfied with the outcome of an administrative review, the case will be raised to the Tax Tribunal Commission (TTC).

The procedures which the tax tribunal works and the compliant process and forms that can be applied by the taxpayers are annexed in this manual. They are also ready and can be found the TTC office and the ministry of finance's website. **sImof.org.**

CHAPTER FOUR: TAX CALCULATIONS

4.1. Business Income Tax

Business tax includes any trade, profession, vocation, or adventure in the nature of trade but does not include employment. Corporate tax is another form of a direct tax. This is the tax that corporations and other businesses must pay to the government on the profits

they earn. However, partnerships and sole proprietorships do not pay corporate taxes.

The corporate tax in the U.S. is separate from income tax. In Somaliland business income means any income derived by a person carrying on a business and its coverage are described under Section 69 of the SRA 2016. Businesses pay income taxes on their earnings; the Inland Revenue taxes income from corporations, partnerships, self-employed contractors, and small businesses. Depending on the business structure, either the corporation, its owners, or shareholders report their business income and then deduct their operating and capital expenses. The difference is their taxable business income. Section 58 (Rate of Income Tax for Companies) of the SRA specifies that the chargeable income of a company for a year of income is charged to income tax at the rate of 10%.

Wegovy: Weight-loss drug firm becomes Europe's most valuable



The maker of weight-loss drug Wegovy has become Europe's most valuable firm, dethroning the French luxury conglomerate LVMH.

Shares rose after the Danish pharmaceutical giant, Novo Nordisk, launched the popular drug in the UK.

At the close of trading on Monday, the firm had a stock market valuation of \$428bn (£339bn).

Famous personalities such as Elon Musk are among the reported users of the drug, which has captivated Hollywood and the public more widely since it was

approved by regulators in the US in 2021.

Fanfare'

There has been a global shortage of the jabs so only limited stock arrived for the NHS in the UK on Monday.

Sophie Lund-Yates, lead equity analyst at Hargreaves Lansdown, told the BBC's Wake Up to Money programme the firm had been "genuinely surprised" by the uptake and said it had been "a victim of its own success".

"It's not common that you see a pharmaceutical company so entrenched in popular culture but there are people saying that we need to take a step back and ensure it is being used appropriately and responsibly. Of course, with a lot of fanfare for a drug, you are risking a lot of blowback in the future," she said.

In the UK, NHS guidelines say patients can only access Wegovy, which contains the drug semaglutide, if they are significantly overweight and have weight-related health problems.

According to the Organisation for Economic Co-operation and Development (OECD), nearly one in three adults are obese in the UK. which is the highest level in Europe. Last month, a new trial showed Wegovy has also been proven to reduce the risk of a stroke or

heart attack.

While the findings still have to be fully reviewed, experts agreed the results were potentially significant.



NHS gets limited stock of

Some NHS patients could be prescribed the Wegovy weightloss drug after limited stock arrived in the UK.

The injection will be offered by some specialist NHS weight-loss management services, as well as some private clinics.

As doses become available, it could help tens of thousands of patients in England, the NHS said.

There has been a global shortage of the jabs, which blunt appetite. The cost to the health service is unclear. What is Wegovy and does it work? Experts warn the jabs - widely used in the US and endorsed by many celebrities - are not a quick fix nor a substitute for a healthy diet and exercise.

In trials, users often put weight back on after stopping treatment.

The Danish maker of Wegovy, Novo Nordisk, said it would continue to restrict global supplies as it works to ramp up manufacturing.

It said in a statement there would be a controlled and limited launch: "As we expect supply to be constrained for the foreseeable future, a proportion of available supply will be allocated for use only within the NHS.

"We will continue to work with healthcare professionals to help ensure that patients with the highest unmet medical need are prioritised. "We are closely monitoring demand and are working with regulators and providers to ensure people living with obesity can have access to and remain on the treatment."

NHS guidelines say patients can only access Wegovy, which contains the drug semaglutide, if they are significantly overweight and have weight-related health problems.

Eligible patient can be prescribed it for a maximum of two years via specialist weight-management services, alongside diet and exercise advice.

These services are largely hospital based, meaning only about 35,000 have access, but the government says tens of thousands more people could be eligible if a new scheme to let GPs prescribe it works.

An NHS spokesperson said: "Despite global supply constraints, NHS England is taking action to begin implementing NICE guidance for weight management, while at the same time working to restore supplies of this class of drug for people with type 2 diabetes.

"Around 50,000 eligible patients in England could be prescribed Wegovy through NHS specialist weight management services, that are able to provide appropriate multidisciplinary care."

A father whose daughter died after travelling to Turkey for weight-loss surgery has urged people to think again before doing the same.

Shannon Meenan Browse from Londonderry was 32 when she died in August.

The mother-of-four travelled for a gastric sleeve operation 18 months ago but, according to her father, got sick almost straight away.

Shane Meenan said his daughter could not keep any food down in the wake of the operation.

He said the illness got so bad her teeth began to rot due to constant vomiting.

The family were told she died in Dr Nicola Herron, a Derry-based GP, said the experience of Ms Meenan Browse and her family was "beyond heart-breaking", adding that doctors increasingly concerned about people travelling abroad for surgery. "The professionals here are sometimes at a loss as to how to look after people who have come back after this major surgery because this is a specialist area. That is very worrying," Dr Herron said.

The two most common types of weight loss surgery are:

 Sleeve gastrectomy or gastric bypass, where some of the stomach is removed or the digestive system is re-routed past most of the stomach

• Gastric band, where a band is used to reduce the size of the stomach so a smaller amount of food is required to make someone feel full

"A sleeve gastrectomy is where a large part of the stomach is removed so it's much smaller than it was before," the NHS website says. "This means you cannot eat as much as you could before surgery and you'll feel full sooner." Risks associated with this type of surgery can include difficulty swallowing, vomiting and, in some cases, serious illness and death. Recalling his daughter's ordeal, Mr Meenan said she couldn't keep her vitamins - nor anything else - down. "As each day passed, she was getting sicker and sicker." 'Nothing they could do' Mr Meenan said the only food his daughter could eat without throwing

In the UK, he said, patients undergo a rigorous preparatory process that includes psychological а assessment and there is "a proper after-care programme".

'Lost my heart and soul' A BBC investigation in March found that seven British patients who travelled to Turkey for weight-loss surgery died after operations there, while others returned home with serious health issues.

In 2019 the Department of Health (DoH) said it was considering setting up Northern Ireland's first dedicated weight-loss surgery unit.

Most people, she added, don't realise just how serious the surgery can be.

Mr Meenan, meanwhile, told BBC **Radio Foyle**, that his daughter's death had lost him his heart and soul.
