This would present a significant threat in allowing terrorist organizations to further enhance the spread of extremist ideology and influence in the region. The Government of Somaliland reaffirms its commitment to protect the security and stability of the Republic of Somaliland against all who threaten Somaliland and the Horn of Africa.



"The Government of the Republic of Somaliland is proving once again to its people and the international community that terrorist groups are constantly flocking to the city of Lasanod.

As already stated by the Ministry of Foreign Affairs and International Cooperation of Somaliland, more than 600 members of terrorist groups, entered the city of Lasanod after the 25th of August.

The Ministry of Internal Affairs is clarifying to the members of the public and the world on where the terrorist groups entered the city of Lasanod, whose major goal is to destabilize the Horn of Africa. 1- The terrorist groups that reached the town of Lasanod and Buhoodle came down from the mountains of the Golis range, especially the mountains around the Pundland Regional Government of Somalia, which are called GALGALA, and are known strongholds of Al-Shabaab and Daesh. 2- The second part of the terrorist groups that arrived in Lasanod, are those who moved from the Central Regions of Somalia, such as the

Lower Shabelle, the Middle Shabelle and other parts of southern Somalia, some of which have since been defeated in the ongoing wars in Somalia.

3- The third group, which is the vastest, came out of a training camp run by Abdi Madobe, who is the representative of the Al-Shabaab group in Buhoodle. These training camps are located in the Horufadi area of Buhoodle and Shululuh area, where Abdi Madobe trained hundreds of youths and convinced them of the extremist ideology of Al-Shabaab.

Search-and-rescue operations in the wake of Storm Daniel in Libya continue, led by national agencies, military, the Libyan Red Crescent and local volunteers.

As of yesterday, according to the International Organization for Migration, more than 2,000 have been killed and at least 5,000 people are missing.

The UN is responding to calls for assistance and is providing aid in the affected areas.

The Resident and Humanitarian Coordinator in Libya, Georgette Gagnon, has tasked an emergency response team to support local authorities and partners.

A 12-person UN Disaster Assessment and Coordination (UNDAC) team has been deployed to support the response and relief operations.

The Under-Secretary-General for Affairs Humanitarian and

Emergency Relief Coordinator, Martin Griffiths, announced yesterday an initial allocation of \$10 million from the Central Emergency Response Fund (CERF) to support people affected by the floods.

Morocco

Five days after the devastating earthquake that hit Morocco, the country's authorities confirm the loss of nearly 3,000 lives and the injury of more than 5,500 people. The Government has mobilized all

necessary capabilities. A small UN team has been deployed to enhance the existing UN capacity, while the UN continues close communication with the national authorities and stands ready to support in the assessment, coordination, and response to the situation.

Sudan

In a statement today, the Humanitarian Coordinator in Sudan, Clementine Nkweta-Salami, called on all parties to the conflict to spare

civilians as attacks continue across the country.

Ms. Nkweta reminded the Sudanese Armed Forces and the Rapid Support Forces that four months ago, on 11 May, they both signed the Jeddah Declaration and committed to put the interests and the well-being of the Sudanese people as their top priority and to protect civilians.

Sunday's attack on a crowded market in Khartoum killing dozens, and the ongoing killing of civilians in Nyala, Al Fasher and other areas underscores the fact that the parties to this conflict are not honouring their pledges. People of Sudan have suffered far too much already, said Ms. Nkweta, calling the Sudanese Armed Forces, the Rapid Support Forces and all armed actors participating in the conflict to respect international humanitarian law and take immediate steps to safeguard civilians.

Ukraine

Early today, there was yet another attack hitting Ukraine's ports in the Odesa Region.

The attack damaged the areas of Reni and Izmail Ports, close to the Romanian border, reportedly injuring several civilians.

The Humanitarian Coordinator for Ukraine, Denise Brown, said the pattern is especially alarming due to its catastrophic implications for the people of Ukraine and for 345 million people facing hunger worldwide.

Hidden high blood pressure in young people revealed



A "considerable" number of young people in England about 170,000 aged 16 to 24 unknowingly have risky high blood pressure, experts are warning.

That is about five in 100 young men and one in 100 young women, says the Office for National Statistics (ONS).

Although it may not cause symptoms or problems to begin with, it puts extra strain on the heart and blood vessels.

High blood pressure, or hypertension, is responsible for about half the heart attacks and strokes in the UK.

It can develop at any age, which is why doctors say all adults should have regular blood pressure checks and take steps to avoid long-term harm.

Chris Shine, from the ONS's analytical hub, told the BBC that they had carried out the new analysis to identify the groups most at risk of having undiagnosed high blood pressure.

"We see that there are considerable numbers of younger, healthier people who are undiagnosed. It may be that this group are unaware they have the condition because they are less likely to access healthcare if they are otherwise well," he said.

"These results will provide valuable insight for health services and those seeking to improve outcomes for what is one of the most common causes of premature death, especially as we know that the sooner hypertension is identified, the more effectively it can be managed and treated among all ages."

About a third of adults in the UK have high blood pressure, but many are not aware of it, experts say. Being overweight, eating an unhealthy diet, not being active, drinking too much alcohol and smoking can all raise blood pressure. According to the ONS, young men were particularly likely to be undiagnosed - 66% of males and 26% of females aged 16 to 24 years, and 55% of males and 44% of females aged 25 to 34 years, compared with 17% of males and 21% of females aged 75 years and over. The data comes from the Health Survey for England, which carried out at-home blood pressure measurements on 20,000 people including 1,500 young people -

 Of those, 26% of the women (about 30,000) and 66% of the men (about 140,000) were undiagnosed Dr Pauline Swift, from the charity Blood Pressure UK, said while some risk factors, such as ageing and ethnicity, are unavoidable, others are within people's control. "In recent years we have seen an increase in younger patients with high blood pressure, often as a result of poor diet, consuming too much salt and lack of exercise leading to weight gain," she said.

"If you start making small changes to your lifestyle when you are young, such as eating less salt, more fruit and vegetables and taking more exercise to maintain a healthy weight, then you are more likely to stay healthier and prevent strokes, heart disease and chronic kidney disease.

"High blood pressure kills thousands of people every year in the UK and is almost entirely preventable.

"Everyone needs to take control of their health by checking their blood pressure either at home, at a pharmacy or with their practice nurse. This could save your life."

Prof Bryan Williams, President of the International Society of Hypertension, and a specialist at University College London Hospitals NHS Foundation Trust in London, said: "I just don't think people realise just how dangerous untreated high blood pressure can be.

According to the position paper which is published in the Journal of Hypertension, there is enough scientific evidence for some less conventional approaches.

One of the authors, UK blood pressure expert Prof Bryan Williams, said in an exclusive interview with the BBC: "It all sounds like it is a bit soft and fluffy and not as dynamic, for example, as taking drugs but these things make such an important contribution to reducing the effects of stress on the cardiovascular system and the evidence is accumulating.

What can help lower blood pressure?

High blood pressure is a leading cause of premature death.

It puts strain on the heart and blood vessels which, in the long term, can lead to heart disease, heart attacks and strokes.

More than a billion people or one in four adults worldwide has high blood pressure.

The panel of experts from 18 countries advise:

 Try daily stress-busting strategies like meditation, deep breathing, yoga and mindfulness

 Consider practising gratitude by focusing on positive things you can Prof Williams, a specialist at University College London, said: "It's not just the duration of sleep but it's also the quality of sleep. And the evidence suggests that most people should be trying to achieve seven hours of good quality sleep to try and reduce the effects of the stress of sleeping and not not decompressing.'



Somaliland Tax System and administration

(Part 19)

A. Allowed Deductions

1) Expenses: Expenses paid by business for the purpose of earning, securing and maintaining the business income.

- 2) Losses: E.g. partial destruction of the company property.
- 3) Operating deficit: Not exceeding three subsequent years.
- 4) Depreciation: Tearing and wearing of company property.
- 5) Gratuities: Amount of money given to somebody provided services to a Company.
- B. Not Allowed Deductions
- 1) Private/personal expenses
- 2) Any withdrawal of capital

3) Any losses/expenses which is recoverable under insurance or indemnity.

4) Rent of any building not paid for the purpose of producing the income.



Scientists discover how brain cells die in Alzheimer's



Scientists in the UK and Belgium think they have figured out how brain cells die in Alzheimer's disease.

It has been a mystery and a source of scientific debate for decades.

But the team, writing in the journal Science, connect the abnormal proteins that build up in the brain with "necroptosis" - a form of cellular suicide.

The findings have been described as "cool" and "exciting", as they give new ideas for treating the disease. Long-awaited clues

It is the loss of brain cells, called neurons, that lead to the symptoms of Alzheimer's, including memory loss.

And if you look inside the brains of people with the disease you'd see the build-up of abnormal proteins called amyloid and tau.

But scientists have not been able to join the dots between these key traits of the disease.

This is what the researchers - at the UK's Dementia Research Institute at University College London and KU Leuven in Belgium - now think is happening.

They say abnormal amyloid starts to build up in the spaces between neurons, leading to brain inflammation, which the neurons do not like. This starts to change their internal chemistry.

Tangles of tau appear and the brain cells start producing a specific molecule (it's called MEG3) that triggers death by necroptosis. Necroptosis is one of the methods our bodies normally use to purge unwanted cells as fresh ones are made.

The brain cells survived when the team were able to block MEG3.

"This is a very important and interesting finding," researcher Prof Bart De Strooper, from the UK's Dementia Research Institute, told the BBC.

"For the first time we get a clue to how and why neurons die in Alzheimer's disease. There's been a lot of speculation for 30-40 years, but nobody has been able to pinpoint the mechanisms.

"It really provides strong evidence it's this specific suicide pathway."

The answers came from experiments where human brain

cells were transplanted into the brains of genetically modified mice. The animals were programmed to produce large quantities of abnormal amyloid.

There has been recent success in developing drugs that strip amyloid out of the brain and they mark the first treatments to slow the destruction of brain cells.

Prof De Strooper says the discovery that blocking the MEG3 molecule can hold off brain cell death could lead to a "whole new line of drugs development".

However, this will take years of research.

Prof Tara Spires-Jones, from the University of Edinburgh and the president of the British Neuroscience Association, told me "that is a cool paper".

She said it "addresses one of the fundamental gaps in Alzheimer's research... these are fascinating results and will be important for the field moving forward."

However, she stressed that "many steps are needed" before knowing whether it could be harnessed as an effective treatment for Alzheimer's.

Dr Susan Kohlhaas, from Alzheimer's Research UK, said the findings were "exciting" but still at an early stage.

"This discovery is important because it points to new mechanisms of cell death in Alzheimer's disease that we didn't previously understand and could pave the way for new treatments to slow, or even stop disease progression in the future."

Millions are dying from drug-resistant infections, global report says

More than 1.2 million people died worldwide in 2019 from infections caused by bacteria resistant to antibiotics, according to the largest study of the issue to date.

This is more than the annual death toll from malaria or Aids.

Poorer countries are worst affected but antimicrobial resistance threatens everyone's health, the report says. Urgent investment in new drugs and using current ones more wisely are recommended to protect against it. The overuse of antibiotics in recent years for trivial infections means they are becoming less effective against serious infections. analysis of 204 countries by a team of international researchers, led by the University of Washington, US.

They calculate up to five million people died in 2019 from illnesses in which AMR played a role - on top of the 1.2 million deaths it caused directly. In the same year, Aids (acquired immune deficiency syndrome) is thought to have caused 860,000 deaths and malaria 640,000. Most of the deaths from AMR were caused by lower respiratory infections, such as pneumonia, and bloodstream infections, which can lead to sepsis. MRSA (methicillin-

Prof Chris Murray, from the Institute for Health Metrics and Evaluation at the University of Washington, said the new data revealed the true scale of antimicrobial resistance worldwide and was a clear signal immediate action was needed "if we want to stay ahead in the race against antimicrobial resistance. France sets out plan to ban disposable vapes

France is set to ban disposable ecigarettes - known locally as "puffs" - because of the danger they pose to the environment and public health. Speaking recently on RTL radio, Prime Minister Elisabeth Borne said the measure was part of a new anti-smoking plan being drawn up by the government. It should be in force by the end of the year, campaigners said.

Several other countries in Europe, including Germany, Belgium and Ireland, have announced similar bans. The UK is also said to be considering one. Sold over the counter by tobacconists, disposable vapes in France cost around $\notin 9$ (£7.70) - less than a packet of 20 cigarettes. They are supposed to offer around 600 puffs - the rough equivalent of 40 cigarettes.

But France's National Academy of Medicine described them as a "particularly sly trap for children and adolescents". According to Élisabeth Borne, "they create a reflex, a gesture, which children get used to, and then end up being drawn to tobacco".

UK health officials recently warned **antimicrobial resistance** (AMR) was a "hidden pandemic" that could emerge in the wake of Covid-19 unless antibiotics were prescribed responsibly.

Particularly deadly

The estimate of global deaths from AMR, published in **the Lancet**, is based on an

resistant *Staphylococcus aureus*) was particularly deadly, while E. coli, and several other bacteria, were also linked to high levels of drug resistance.

Using patient records from hospitals, studies and other data sources, the researchers say young children are at most risk, with about one in five deaths linked to AMR being among the underfives.

Deaths from AMR were estimated to be:
highest in sub-Saharan Africa and South Asia, at 24 deaths in every 100,000
lowest in high-income countries, at 13 resistance levels in different countries and regions is essential.

Dr Ramanan Laxminarayan, from the Centre for Disease Dynamics, Economics and Policy, in Washington DC, said global spending on addressing AMR needed to rise to levels seen for other diseases.

"Spending needs to be directed to preventing infections in the first place, making sure existing antibiotics are used appropriately and judiciously, and to bringing new antibiotics to market," he said.
