The NEC awards candidacy certificates to presidential and vice-presidential aspirants

This week testifies to the readiness in preparations for the electioneering processes for the upcoming presidential and vicepresidential elections which will be

held simultaneously with that of the

political parties. The Somaliland National Elections Commission (NEC) on Saturday awarded the candidacy certificates to the three presidential aspirants who are vying for the top executive post in the country.

The incumbent H.E. Musa Bihi Abdi who is the flag-bearer of the ruling party KULMIYE arrived at the headquarters of the elections body lin the morning while quite jovial.

So too did his challengers Abdillahi Mohamed Abdillahi Irro and Feisal Ali Hussein of respectively both WADDANI and UCID political parties arrived at about the same time to receive their certificates of candidature.

All were accompanied by their running mates.

Upon the presentations words of wisdom were expressed by the Chair of the commission Mr. Musa Hassan who quipped that the air of camaraderie depicted should be also seen all throughout the elections period such that the processes may be without flows. The Head of State on his part noted that pledge should be made that the elections would be entered without incidences. He further cautioned that since the nation had so many foes, things that would foment or catalyze animosity should be totally shunned.

The WADDANI aspirant Abdillahi Irro said that he welcomed his fellow aspirin candidates and pointed out that he was ready for the elections hence would standby any directives from NEC.

On his part, UCID aspiring candidate Feisal Ali observed that the flagbearers should prevail upon their supporters who spew virulent words otherwise they would be seen to abetting the wrongs.

The NEC received on Thursday the candidacy documents for Presidential and Vice-Presidential candidates from the three National Parties, marking a crucial step toward the upcoming elections to be held on the 13th of November this year.

The Somaliland National Electoral Commission (NEC) had conducted a lottery draw for Political Parties and Associations to establish the order of their listings on the ballot papers for the Presidential and National Party Elections set for November 13, 2024.

This is after the final list of political

associations and parties eligible to participate in the National Party Election was availed, an announcement which was a significant milestone in the electoral process.

Meanwhile, Taiwan had revealed earlier in the week that it would eke in spport in funding the elections. NEC welcomed Taiwan's Ambassador Allen Chen Lou, to their HQ.

Present was Somaliland's Ambassador to Taiwan, Mohamed Haji.

The NEC briefed them on preparations for the upcoming elections whereupon Amb. Allen pledged Taiwan's financial support for the elections.

In related news, the National Electoral Commission witnessed the administering of oath to regional and district election officials at the wrapping up of a training that they underwent.

The Chairman of the commission, Musa Hassan, urged the officials of the regions and districts of the national commission to ensure diligence in the performance of their duties.

He reminded them that the oath they undertook was a solemnity pledge whose responsibility they only bore upon their own selves.

President unveils the 4th Political Program of the KULMIYE Party Policy Programme

He wondered whether the move by the WADANI aspirant was ethical and left the query to the institution charged with the election management and the members of public at large to interpret.

He called for the adherence of expected legal tenets and ethical standards as prescribed in the election regulations that discern such intricacies.

Somaliland tells diplomats in Hargeisa MoU with Ethiopia finalized, formal legal agreement imminent

The Ministry said Dr. Essa Kayd informed the diplomats he met with that the Memorandum of Understanding (MoU) between Somaliland and Ethiopia "is finalized, and a formal legal Party (PP) said that the party has decided to bring the MoU "to a practical agreement" while simultaneously giving attention to secure additional options to port

The ruling party maintained the MoU was a testament to "Ethiopia's position for regional economic and cultural ties." The signing of the MoU on 01 January 2024, granting Ethiopia access to the sea in return for international recognition for Somaliland, has escalated tensions in neighboring Somalia, which argued that the MoU "violates its sovereignty and territorial integrity". Two rounds of talks facilitated by Türkiye aimed at easing tensions between Ethiopia and Somalia have concluded without an outcome. The tensions between the two neighboring countries have since



agreement is imminent."

This is the second major statement about the MoU from Somaliland after its announcement in February this year that Somaliland was "on course without any wavering, and remain seized" of the implementation of the MoU, and that a technical team, a team of international legal experts and a high-level advisory group to advise and guide the process has been appointed.

Although Ethiopia has since been largely quiet about any practical progress on the MoU, in a resolution issued in January, members of both the Executive and the Central Committee of the ruling Prosperity peaked momentum, leaving a trace of doubts on the likelihood of a third round of talk.

Egyptian forces in Somalia During the briefing today, Dr. Kayd also expressed the Somaliland government's deep concerns regarding the presence of Egyptian military forces in neighboring Somalia.

In July this year, Somalia's cabinet formally approved the implementation of a defense agreement with Egypt, finalizing a deal shrouded in secrecy since its signing in January 2024.

Premier Abiy also emphasized that the Ministry of Defense and its personnel are not only well-versed in this practice but also deeply committed to it as a fundamental part of their lives.

The premier mentioned that Ethiopia has never engaged any conflicts with its neighboring countries in the past six years, explaining that the peace and security of these neighboring nations contribute significantly to Ethiopia's own peace, security, and successful development.

He emphasized that the people near and far are Ethiopians. We don't

need things owned by others. But if anyone seek to harm or influence us will be met with shame and returned in accordance with our traditions.

The Prime Minister stated, "We Ethiopians do not have any desire to take others' belongings and engage in conflict with any country," reiterating Ethiopia's commitment to ensuring sovereignty in all spheres.

He highlighted that Ethiopia's defense force is an army that serves not only Ethiopia but also the broader region, emphasizing that this army should not only maintain peace but also contribute to accelerating development.

The Prime Minister called upon all Ethiopians, regardless of their profession, to work diligently and contribute to the prosperity of the country, per ENA.

Maverick traditional leader Boqor Osman aw Mohamoud popularly known as Buurmadow has stated that as far as the country's and its people' aspirations was concerned, no one would be able to subvert.

The traditional leader gave the sentiments as he triumphantly jetted back after several years into the country owing to Presidential Pardon extended him recently.

He noted in one of his speeches, as he addressed several similar receptions that toasted to his safe return, that he was not able to swiftly return to the country owing to the constitutional requirement that whoever visits Mogadishu was not to be allowed back in the country unless granted pardon by the state. He said that it was because of the legal aspect of the fact that he had no other option except seek and wait for a pardon.

He pointed out that he was thankful

that even after all the rhetoric he spewed in the media over the years including sharp words against the head of State, "the President had not even once scoffed at him"

State reveals legalizing MoU agreement with Ethiopia is imminent

The government of the Republic of Somaliland has ordered the official closure of the Hargeisa Cultural Library of the Egyptian government in the capital of Somaliland, Hargeisa.

National The Electoral Commission has received the final list of the political organizations which will compete with the three existing political parties in the forthcoming elections for the top three slots of the national official parties for a ten-year period.

The national committee for the registration and verification of political associations and approval

of political parties presented seven names of political organizations which would formally enter the race in the said elections that are scheduled to be held on the 13th of November 2024.

The presidential and vice presidential elections would be simultaneously held on the same day.

- 1. Barwaaqo Association
- 2. Talo-wadaag Association

3. Rajo Association 4. Shacabka Association

- 5. KAAH Association
- 6. Hilaac Association

7. Horseed Association The seven political organizations would thus try to unseat KULMIYE, WADDANI and UCID who are defending their officialdom to be the only three operating political parties in the country for a period of ten years as per constitution.

Finance Ministry seeks Council of Ministers' approval for salary increases ranging from 5% to 332% for 2.4 million public servants



The Ministry of Finance has submitted a proposal to the Council of Ministers requesting formal approval for a substantial salary increase for approximately 2.4 million public servants.

If approved, the adjustment would take effect on 11 September, 2024. In a letter dated 03 September, 2024, and addressed to the Prime Minister's Office, Finance Minister Ahmed Shide outlined the proposed salary increase. The adjustment would require an additional budget of 91.4 billion birr.

This proposal follows a recent announcement by Prime Minister Abiv Ahmed regarding significant salary increases for public servants. The Ministry's proposal is accompanied by a comprehensive study that provides detailed justification for the proposed salary increases.

According to the letter, the national committee macroeconomic reviewed the study before it was submitted to the Council of Ministers. The study indicates that 2.4 million government employees would benefit from the proposed salary adjustment. This includes 2.3 million federal employees, as well as members of regional police forces, the Ethiopian National Defense Force (ENDF), and the Federal Police Commission. Citing a survey conducted by the Ethiopian Statistical Service in June 2022, the study reveals that of the 2.3 million civil servants, 1.1 million (47.94%) earn less than 6,000 birr per month. This group is classified as living below the extreme poverty line.

Another segment, comprising 946,306 civil servants, earns between 6,000 and 10,000 birr per month and is considered to be living below the standard poverty line. Additionally, approximately 253,297 government employees earn more than 10,000 birr monthly.

The study concludes that close to half of government workers are living in extreme poverty and are disproportionately affected by rising living costs.

To address the financial hardship faced by these civil servants, the study recommends a significant salary increase for lower-income employees, proposing a wage increase of up to 332%. This would raise the minimum monthly salary for a government employee from

1,100 birr to 4,760 birr.

Prior to the adjustment, commercial banks were trading the birr at approximately 56.55 to the dollar. By 05 September, 2024, the buying rate at the state-owned Commercial Bank of Ethiopia (CBE) had risen to 106 birr per dollar.

The depreciation of the local currency has led to a noticeable increase in prices throughout the country, particularly in Addis Abeba. This has placed additional financial strain on fixed-income earners, such as civil servants.

Prices for certain goods, especially imported items and essential domestic products like oil, sugar, and onions, have risen significantly in various markets across Addis Abeba.

According to traders in Merkato, the price of a five-liter container of cooking oil has increased from 900 to 1,200 birr since the implementation the of macroeconomic reforms. Similarly, the price of sugar has risen from 100 birr per kilogram to 116 birr. In addition to its impact on fixedincome earners, the World Food Program (WFP) has recently expressed concern over the increasing challenges it faces in ensuring safe and timely food deliveries to Ethiopia's most vulnerable populations. The WFP attributes these challenges to rising inflation, among

Ethiopian FM raises concerns over 'post-ATMIS arrangement', calls for AGOA restoration in talks with US envoy



Ambassador Taye Atske-Selassie, Ethiopia's Foreign Minister, expressed "concerns the post-ATMIS over arrangement" during a meeting on 13 September 2024 with U.S. Special Envoy for the Horn of Africa, Ambassador Mike Hammer, according to the Ministry of Foreign Affairs.

The ministry reported that the meeting addressed broader peace and security issues in the Horn of Africa, with Foreign Minister Taye reiterating Ethiopia's commitment to "deescalating tensions in the region."

Additionally, FM Taye called for the restoration of Ethiopia's status under the African Growth and Opportunity Act (AGOA), urging the U.S. to reconsider Ethiopia's eligibility for the trade benefits program, according to the ministry.

The meeting followed a press briefing earlier that day by Ambassador Hammer, where he clarified that while the U.S. government would like to see Ethiopia return to AGOA, human rights concerns remain a key obstacle.

"There is a requirement that there not be any violations of human withdraw, as outlined in the rights by government forces," Hammer explained. "As long as abuses and atrocities continue, reintegration into AGOA will not be possible." The two officials also discussed the current situation in the Tigray region. Ambassador Tave

confirmed the country's dedication to the "full implementation of the Pretoria Peace Agreement," the ministry stated.

Hammer, who had recently returned from a visit to Tigray, told reporters earlier that day that Tigray authorities remain committed to the Pretoria Agreement and urged them to resolve internal divisions within the Tigray People's Liberation Front (TPLF) through dialogue.

He acknowledged progress since the Pretoria Peace Agreement but stressed that more work remains: "We are not satisfied with the amount of progress, but some progress has been made." Hammer highlighted the importance of disarmament, demobilization, and reintegration (DDR) of former combatants and reiterated U.S. support for the return of displaced persons.

Hammer also addressed concerns over the continued presence of Eritrean forces in Tigray, stating, "There are still concerns about the lingering presence of Eritrean forces." He reaffirmed the U.S. position that all non-ENDF forces must fully Pretoria Agreement. In addition to Tigray, Hammer expressed concern over violence in the Amhara and Oromia regions, emphasizing that "these conflicts do not have military solutions" and must be resolved through dialogue. AS

On the other hand, those earning the highest monthly salary of 20,468 birr would receive a 5% raise, amounting to an increase of 1,023 birr.

agency, the depreciation of the birr, from resulting recent macroeconomic policies, is expected to have a direct negative impact on impoverished households.

"The introduction of free-floating exchange rates and the subsequent depreciation of the birr are anticipated to have an immediate detrimental impact on poor households," WFP forecasted. "Elevated food prices are one of the main factors contributing to acute food insecurity by restricting economic access to food." AS

4. FINANCIAL SYSTEM INFRASTRUCTURE DEVELOPMENT AND RISKS

This chapter discusses developments and risks for the stability of Ethiopia's financial system related to the infrastructure of the financial system. The infrastructure comprises currency management, the payment and settlement system, credit market infrastructure, and financial inclusion & consumer protection.

4.1 NATIONAL PAYMENT SYSTEMS DEVELOPMENT

Payment systems in Ethiopia were radically modernized in 2011 aµer NBE launched the Ethiopian Automated Transfer System (EATS), a modern clearing and settlement system. NBE owns and manages the payment system infrastructure. It includes the Real-Time Gross Settlement system (RTGS), which provides facilities for final settlement of payments between financial institutions; **27** and the Automated Clearing

House (ACH), which provides clearing and netting services for bulk payments. **28** Before 2011, all payments in the country, including bank-tobank transfers, were made through the exchange of letters; as a result, a single interbank transfer took days to be settled.

The dependency of the financial sector on the RTGS infrastructure has increased.

Therefore, the safety and e¢ciency of RTGS has become critical for the stability of the financial system. The regulatory framework, which plays a very important role in this, needs to be constantly updated in line with technological and financial sector developments.

Payment System Regulatory Framework and Developments

The legal and regulatory framework plays a critical role in creating a safe, secure, and e¢cient enabling environment for inclusive payment services. The national payment system Proclamation No. 718/2011 and Proclamation No. 1282/2023, the payment

system operators Directive No. ONPS/02/2020 and the payment instrument Directive No. ONPS/09/2023, among others, all constitute the current active regulatory framework to ensure the safety, security, and e¢ciency of the national payment system.

NBE has also taken initial steps toward enabling digital payments through the development of infrastructure, encouraging adoption of digital payments, revising regulations, and promoting innovation by launching National Digital Payments Strategy (NDPS). The vision of the NDPS is to

The U.S. "working with partners" resolve Ethiopia-Somalia tension



Citizens reports on social media from sources with Mogadishu to Mogadishu seem to suggest that the Hassan Sheik Mohmmed government is taking a more radical stance against Ethiopia and even moving in the direction of making claims of Ethiopian territory in Ogaden as part of Somalia. But the U.S. is reportedly expressing optimism that the tension will be resolved diplomatically. According to the VOA Amharic report, the United States is working with its partners (unspecified) in that direction. Richard Riley, U.S. Ambassador to Somalia, cited as saying "in the current situation his country is working in collaboration with others in search of a diplomatic solution." According to the Ambassador, the U.S. and its partners are approaching the Federal government in Somalia and the government in Addis Ababa. The Ambassador also made a reference to the Turkish initiated talks between Ethiopia and

Somalia. "The next one will be started in a few days, " he said.

Asked if the situation could lead the two countries (Ethiopia and Somalia) to war, the Ambassador said "no." He added "let alone war, no one accepts the chance for the outbreak of any conflict. That is why the international community and all are relentlessly working to resolve the issue. The effort of the United States is to find a solution for the situation between Ethiopia and Somalia. " From the VOA Amharic report, it seems that the United States wants the resolution of the tension between the two countries quickly. "The absolutely necessary issue is this. It should happen quickly and now," Ambassador Richard H. Riley is quoted as saying. Last month, Somalia signed a defense pact with Egypt, which is deploying 10,000 troops in Somalia. There were reports in

social media this week that Ethiopian forces controlled some airports in Somalia but the Ethiopian government has not confirmed or denied it

Somalia and Ethiopia have a history of conflict and hostility. The recent one developed in January 2024 when Ethiopia and Somaliland

A. Ethiopian Automated Transfer System Source: NBE Database At end-June 2023, 32 financial institutions had participated in EATS, of which two were MFIs. No major system interruption on EATS was reported in the year. The system processed more than Birr 3.9 million transactions (up by 35.2 percent from the previous year) with a value of more than Birr 4.8 trillion (an annual increase of 28.7

percent).

B. Digital Financial Services (DFSs)

Following a recent NBE directive, domestic non-bank payment service providers are allowed to issue electronic money instruments and/or obtain a payment systems operator license to provide payment and remittance services. Table 13 shows the development of DFS access points since 2019.

ATMs: The number of ATMs throughout the country grew by 13.9 percent from the

previous year to 7,858 at end-June 2023.

Mobile Money Agents: The number of mobile money agents increased by almost half (48.5 percent) from the previous year and reached over 233 thousand at end-June 2023. The increase is mainly attributed to the entry of Telebirr in the market.

POS: The number of POS terminals deployed within financial institutions and at merchant locations increased slightly from the previous year by 2.2 percent to 12,016 at end-June 2023. Going forward, they are expected to expand further at a faster rate through the concerted e.ort of the private sector and the relevant authorities.

Debit Cards: The number of debit cards rose from the previous year by 25.1 percent to 38.4 million at end-June 2023 – a three and half fold increase in just four years.

Mobile Banking: Currently, mobile banking is considered to be the most convenient and accessible digital payment channel. Consequently, the number of registered accounts increased from the previous year by two-thirds (67.5 percent) to 27.3 million at end-June 2023.

The number of **mobile money/wallet** users increased by 58.7 percent from the previous year to 68.7 million at end-June 2023. The rapid growth was largely attributed to the introduction of Telebirr mobile money services by Ethio-telecom.

Internet banking is still relatively in its infancy with 6.8 million users at end-June 2023 but is growing rapidly.

The arrangement was for Ethiopia to get access to 20 kilometers of coastal land for maritime and commercial purposes on a fifty year rental basis. In return, Ethiopia is to recognize Somaliland – a breakaway region that existed as a de facto state for over 33 years – as an independent state.

The finalization of the arrangement was meant to be completed within one month after the MoU agreement. It took longer than that. Somaliland authorities this week announced the agreement is finalized but it is not made public. Digital payments are growing at an exponential rate (Table 14). At end-June 2023, payments worth more than Birr 4.7 trillion were processed digitally, almost three times the value of the previous year. This growth is the result of successful implementation of the National Digital Payment Strategy and NBE's reform activities.
