The President expressed the sentiments as he addressed the nation's senior traditional leaders at the Presidency where hosted a luncheon in their honor

President meets ICRC/ SRCS delegation

This was reiterated and affirmed during a meeting the President of the Republic of Somaliland, H.E. Abdirahman Mohamed Abdillahi Irro held on Tuesday at the Presidential Palace with a high-level delegation from both the ICRC/SRCS organizations.

The Head of State thanked the delegation for their visit and commended the excellent humanitarian work the organizations are doing in Somaliland.

The President of the Republic of Somaliland acknowledged the important role these organizations play in responding to humanitarian needs, especially in health, prisons, the disabled and in the restoration of family links.

He reaffirmed the state's commitment and the importance it attaches to peace and stability in the region, hence stating that efforts for peace, stability, reconciliation and welfare of the Somaliland community are the top priorities and priorities of the government.

Mr. Antoine Grand, Head of ICRC

Somaliland/Somalia congratulated the President on his victory in the presidential election, praising Somaliland for the mature democratic process that has been implemented in Somaliland.

The official gave the President a general briefing on the history and activities of the ICRC in Somaliland. He particularly highlighted the support that the organization provides to Somaliland, especially in the areas of prisons and health sectors and medicinal supplies.

He also highlighted the strong partnership with the ICRC and the Red Crescent Societies, as well as the support received from the Red Cross Societies of the United Kingdom, Canada, Denmark, Finland, Germany and Norway.

The meeting concluded with an understanding to further strengthen cooperation and partnership between the ICRC, SRCS and the government of Somaliland to address the current humanitarian needs.

Oh, So That's Why Ilhan Omar Is Upset About USAID's Funding Freeze



Far-left Squad member Rep. Ilhan Omar (D-MN) is apoplectic over President Donald Trump freezing all foreign funding from the U.S. Agency for International Development (USAID). Speaking at a press conference outside USAID's headquarters in Washington, she said that the U.S. international aid agency's "essential" programming kept her family fed and safe when they lived in a Dabaab refugee camp for four years at the outbreak of the Somali civil war. (From there, the U.S. granted Omar refugee status and ultimately naturalized citizenship, a process which involved Omar taking an oath renouncing all allegiances.)

Omar, the first Somali American congresswoman, has a record of advancing a Somalia First agenda while in office, seeming to view her job in Congress as representing the interests of her home country. "While I am in Congress, no one will take Somalia's sea," Omar once declared in Somali, according to an English translation. "The lady you sent to Congress is on this, and she is as cognizant of this interest as you are." Omar, who was addressing her Somali American constituents in response to a dispute over Somalia's waters, reportedly said, "The U.S. government will do what we ask it to do. We should have this confidence in ourselves as Somalis."

So it's no wonder why she went ballistic about USAID's funding freezing. Through USAID, the United States is the single largest donor of humanitarian aid in Somalia. Since fiscal year 2022, USAID has sent Somalia massive sums of taxpayer money, nearly \$2.3 billion to date, including direct cash transfers to Somali families in need, who receive monthly payments and vouchers for a period of time. As recently as December, USAID dispensed another \$29 million to help feed 7 million Somalis facing food insecurity. The latest USAID funding came as part of two five-year programs aimed at assisting 880,000 households in south central Somalia.

In FY 2022 alone, the U.S. poured \$1.3 billion of assistance into Somalia, four times greater than the contributions of all other countries combined and accounting for more than 80 percent of the World Food Program's emergency operations in the Horn of Africa. That year, USAID and the U.S. State Department gave \$275 million in "other assistance," a majority of it military aid for Somali and African Union (AU) forces, according to the <u>Congressional</u> <u>Research Service</u>.

Also in 2022, President Joe Biden approved the deployment of U.S. troops there to "reestablish a small, persistent U.S. military presence in Somalia," reversing Trump's decision to pull some U.S. special forces out. As of July 2023, roughly 450 U.S. military personnel were deployed in Somalia to advise and assist Somali and AU forces. As one of Somalia's top national security partners, the U.S. has donated weapons and ammunition to the Somalia National Army (SNA). According to the U.S. Embassy in Somalia, in February 2023, two U.S. Air Force C-17 cargo planes landed at Mogadishu's Aden Adde International Airport carrying 61 tons of AK-47s, heavy machine guns, and ammunition destined for the ground component of the Somali Armed Forces.

However, one of USAID Somalia's main concerns is <u>tackling the</u> <u>purported threat of climate change</u> in the East African nation.

In the spring of 2024, USAID officials met with Somalia's Minister of Environment and Climate Change to discuss how to "mitigate the impacts of climate change in Somalia," which climate alarmists say is the second-most vulnerable country to climate change in the world despite apparently contributing only 0.03 percent of the total global greenhouse gas emissions. Then that September, USAID hosted a summit in Mogadishu that assembled Somalia's top thinkers to pitch ways to address "climate challenges."

Accordingly, USAID Somalia has heavily invested in <u>"climate-resilient"</u> farming practices. In June, USAID announced the launch of TRANSFORM, a \$25 million USAID-funded project promoting "climate-smart" agriculture in Somalia and revitalizing the Jowhar Canal's irrigation infrastructure after it fell into disrepair during the country's civil war. The program, which teaches Somali farmers to use their land more productively and "sustainably," involves conflict mitigation, land tenure management, as well as brainstorming durable solutions for displaced populations. "Together, we will foster a brighter future for all Somalis," said USAID spokesperson Sheri-Nouane Duncan-Jones, the mission's director.

Some of USAID's similar initiatives include introducing <u>"climate-tolerant" fodder seeds</u> to Somalia's terrain, thereby bolstering their livestock-dependent populace against droughts; <u>sponsoring</u> <u>farming schools</u> that have, so far, trained more than 64,000 <u>"climatesmart"</u> Somali farmers on <u>"climatesensitive" techniques</u>; installing <u>a</u> <u>solar grid</u> in the city of Baidoa; and supplying <u>"clean" cookstoves</u> to help refugees, who are displaced due to droughts or flooding, reduce their environmental impact.

USAID claims that Somalia's natural disasters like droughts and floods are linked to climate change. To combat the "climate impact" and empower "climate resilience," USAID's "safety net" Long-Term Cash and Livelihood Assistance Programme provides immediate relief in impacted areas, focusing specifically on those who previously benefited from emergency cash aid. The primary goal of the program is to disrupt the cycle of Somalis returning to a state of food scarcity after emergency intervention by training them to save money and invest. Approximately 13,300 agropastoral households have participated in the USAID-financed program.

USAID also funds "sexual and reproductive health" services for Somali women and girls at medical clinics across the city of Beletweyne. Since 2016, USAID has additionally focused on helping Somalia reestablish itself as an international exporter of sesame seeds. Once one of the world's leading exporters of sesame, Somalia lost its competitive edge, with Somali sesame farmers planting poorquality seeds and lacking adequate training. USAID saw Somalia's "potential" to return to its former glory. Under the auspices of USAID, experts have trained over 5,740 Somali farmers and set up 75 demonstration plots to test new seeds. This effort was part of a fiveyear, \$74 million USAID program promoting "inclusive economic growth" in Somalia. In order to restabilize the region, USAID has worked to implement rule of law in Somalia, where Shari'ah law holds high legitimacy. Legislation, which has not been reviewed in decades, is rarely applied, and most court officials have not been trained in Somali law (standardized curriculum doesn't exist), possess a rudimentary understanding of Somalia's statutes, and follow customary procedures in practice, a five-year USAID study found. According to federal funding records, between 2007 and 2013, USAID spent \$10.8 million on strengthening Somalia's elections process and legislative svstems



The African Union must resolve the Somaliland-

The African Union (AU) can no longer afford to ignore the longstanding dispute between Somaliland and Somalia. This unresolved conflict is not just a bilateral issue; it threatens the stability of the entire Horn of Africa and, by extension, the peace and security of the continent. A decisive and binding resolution is long overdue.

At the heart of this dispute is Somalia's claim over Somaliland's sovereignty-an assertion that directly contradicts the African Union Charter, particularly the 1964 Cairo Resolution, which upholds the sanctity of post-colonial borders. However, Somaliland's independence predates its ill-fated union with Somalia. On June 26, Somaliland 1960. gained independence from Britain, becoming the first independent state in the Horn of Africa and the 17th in Africa. Later, it voluntarily entered a union with Italian Somalia, but this merger was never legally ratified. In 1991, after decades of marginalization and violent oppression, Somaliland rightfully reclaimed its sovereignty. Its case is not one of secession but of restoring an independent status it had already attained.

Somaliland's legal case is strong. It achieved full independence and never formally transferred its sovereignty to another state. The 1960 Act of Union, intended to formalize its merger with Somalia, was never ratified by both parties. Somalia unilaterally implemented a version of this act in 1961, violating international legal norms. That same year, a constitutional referendum in Somalia saw an overwhelming rejection from Somaliland's voters, with 60% opposed-clear evidence of widespread resistance to the union. In December 1961, Somaliland military officers attempted a coup to restore their nation's independence. When captured, they were acquitted by Somali courts, which ruled that no legal framework for the union existed. The African Union's own fact-finding mission in 2005 later concluded that Somaliland's merger with Somalia was never legally binding and that the union had failed between 1960 and 1991. Beyond legality, Somaliland's claim to statehood is rooted in painful history. Under the dictatorship of Mohamed Siad Barre, the Somali government waged a brutal campaign against Somaliland's people in the 1980s, culminating in genocide. Tens of thousands were killed, cities were bombed, and entire communities were destroyed. Survivors of these atrocities have yet to see justice. It was in the aftermath

of this devastation that Somaliland reclaimed its sovereignty, restoring its original independence rather than forming a new breakaway state. Since then, Somaliland has built a functioning democracy with multiple peaceful transitions of power. In 2001, it held a constitutional referendum in which over 97% of voters supported independence, further solidifying its legitimacy. Unlike Somalia, which continues to struggle with political instability, terrorism, and weak governance, Somaliland has maintained peace, order, and a oneperson, one-vote electoral systeman achievement unmatched in much of the region.

Yet, despite its stability and democratic progress, Somaliland's lack of international recognition has imposed severe hardships. It remains excluded from institutions such as the World Bank, the IMF, and the African Development Bank. Foreign investment is limited, hindering economic growth and diplomatic engagement. More importantly, without formal recognition, Somalilanders are denied the full rights and protections that citizens of recognized nations enjoy.

The argument that recognizing Somaliland would set a dangerous precedent is misguided. Somaliland is not a separatist movement; it is a nation that had already gained independence before voluntarily entering an unratified and dysfunctional union. Its case is entirely distinct from those of South Sudan or Eritrea. If any territory in the world has the legal and historical foundation for statehood, it is Somaliland.

The African Union must act. This dispute will not resolve itself, and continued inaction only increases the risk of conflict. Somalia's persistent claims over Somaliland's territory, in violation of international agreements, could ignite further instability in the region. A final and binding resolution is necessary not only to bring justice to Somaliland but to ensure long-term peace in the Horn of Africa. Contrary to statements attributed to U.S. Secretary of Defense Peter Hegseth, the airstrikes in question did not target or impact the Golis Mountains within the territory of the Republic of Somaliland. Instead, these operations were carried out in the Galgala Mountains, located in Puntland, a region within Somalia. The Republic of Somaliland reiterates its status as a sovereign and independent nation, with its own democratically elected government, institutions, and clearly defined borders. The U.S. administration is fully aware that Somaliland is not part of Somalia or any of its regional states. Any misrepresentation of Somaliland's territorial integrity is inconsistent with the longstanding recognition of our distinct political and geographical identity.

President names a national committee to address Ida'ada fire disaster

The President H.E. Abdirahman Mohamed Abdillahi Irro has name a national task-force committee to assess the damage caused by the fire that engulfed the Ida'ada open air market that caused untold damage to the properties of the merchants operating at the area. This happens to be the umpteenth time that fires have razed down several markets in the country in the past few years, the worst of all so far being the Waheen market that saw multi-million dollars worth of properties vanish through fires that dented the national economy severely.

Following this latest one last week, the Head of State who personally went to the location and witnessed the extent of the damage pledged government support.

He has now named the 11-man committee that consists of seven cabinet ministers and four other top officials that include the city mayor, and the attorney general. According to a press release signed by the President, the appointed officials have been specially advised on their imminent tasks hence other institutions of the government, entrepreneurs and the members of the public asked to lend hand whenever and wherever necessary. The press release of the appointment and instructions read as follows: -"As you know, there have been recurring fire disasters in our country lately, which usually occurs in commercial areas, whose disaster causes extensive damage to the property of the public, human lives and the economy of the country in general. "Fire disasters also occur in residential areas where the poor live, causing many houses where the poor lived to burn down, and also causing civilian casualties. "Therefore, bearing in mind the government's responsibility to provide care and assistance to the business people who lost their livelihoods in the fire that broke out

at the Ida'ada Market in Hargeisa, and also aware of the government's responsibility to find a solution to the fire disaster that has been recurring in recent times, I have appointed you to be the National Committee for Damage Assessment and Assistance for the Idaa'ada Market Fires, which would be responsible for the following tasks:

Assessment of the extent 1. of damage caused by the fire that broke out at the said market in Hargeisa:

2. Managing and coordinating emergency activities to support those who have been affected by the fire;

Advising on the causes and 3. finding solutions to the fire disaster, in order to prevent recurrent of similar disaster from causing further damage to the lives and property of the people of Somaliland;

The following are the members of the committee:

Minister of Public Works, 1. Land and Housing -(Chairman).

2. Minister of State for Home Affairs and Urban Development-(Deputy Chairman)

Minister of Commerce and 3. Tourism -(Secretary)

Minister of Information, 4. Culture and National Guidance-Member

Minister of Interior and 5. Security- Member

Minister of Religion and 6. Endowments -Member Minister of Mines and 7. Energy- Member Mayor of Hargeisa -8. Member

He instructed them to be diligent in their duties hence ensure that they are in line with the plans, policies and commitments made by the current government during the

electoral campaign, and said: "The DG must responsibly and fully assume the responsibilities of his/ her job. The responsibility entrusted to you is not only the daily work of the ministry; but it also includes ensuring that the performance and services provided are in line with the policies and plans of the government."

He urged them to keep up with the rapid changes in the world and develop their understanding, and said: "In order to make work easier

The President stated that he would closely monitor the work of the various ministries for which the DGs are responsible hence have them accountable.

He said: "As President, I will closely monitor the progress of the work of each ministry, and you will be held accountable for that."


