corruption is concerned. He at the same time revealed that the government has re-kindled its foreign relations with several countries hence at the same time strengthened them.

The statements were part and parcel of the President's speech as he addressed a large audience on Wednesday at the Presidency at a documentary event that gave the presentation of what the administration has done in its 100 days in office as per its pledge.

He said, "We have strengthened our foreign policy, as our aspiration is to become an independent country. He stated, "I remind you that every decision we make, every action we take, every criticism made, will have an impact on the people's trust in us again".

He noted the first hundred days of the government's activities were based on the basis of the WADDANI party's political program, which consisted of the pillars documented.

pointed out that his administration was open to positive and constructive criticism, while saying, "We are not here tonight to boast to the people, but we are here to tell the people what we have achieved in the past hundred days. I tell all the various officials that every citizen has the right to criticize us, and we should listen and confidently respond to or correct any criticism that is made of us."

The President said that the government has undertaken difficult tasks in the past 100 days and was thankful that he got support.

He was thankful that as concerns the absorption and integration of the various local communities' militia forces into the mainstream national armed forces, the task and effort are almost complete and that only a few lots remain, which he said that he expects it to draw to close in the coming days.

"We have embarked on the program to modernize the various national forces, which has also ended. I am grateful to the ministerial committee that I appointed for this task, the technical committee, and the Electoral Commission, who also gave us great support in implementing this task", he said.

The President of Somaliland also said that his government is up to reform the country's economic system; he said, "We are striving to reform our economic system and modernize it, which will enable the financial institutions, led by the Ministry of Finance and the Central Bank, to make our economic system based on accountability".

He added, "As mentioned, we have stopped all the institutions that used to collect private revenue. Every shilling that the government receives today goes directly to the Treasury. We have decided that every shilling that this nation owns will go to the government treasury". The President of the Republic of Somaliland H.E. Abdirahman Mohamed Abdillahi Irro delivered his maiden State of the Nation Address to the bicameral National Assemblies Parliament in a speech that gave the pointers of his administration as one that is seriously bent on working for the development and aspirations of the people and nation of Somaliland. The speech on Sunday came after the Head of State completed his first 100 days in office that ambitiously put in place his party's manifesto plans, campaign

the national development plans hence dutifully adhered to them. Indeed, the first three months of the administration has surpassed expectations especially operating under duress owing to the prior situation inherited.

He has revealed that the first guarter of this year's economic growth has just registered 19% higher than the previous couple of years.

He has just announced the creation of the national reserve security services, the National Reserve Forces, as he had earlier pledged and promised over three months earlier in his inauguration speech. It is worth noting that few, if any, contemporary leaders in both the developing and developed world have ever adhered and managed to successfully adhere to and implement their 100 days focus precisely as pledged.

The President's speech shed light on all aspects in general as concerns socio-economical, security, political, agricultural, fisheries, livestock, energy, health, educational and infrastructural aspects that are being addressed and the plans in store to bolster

In essence, the President who has seemingly given his appointees leeway to embark on their duties diligently as expected, has indeed been leading with hands-on-the-job hence acutely aware of all the undertakings at, and in, every front and directing them at the same

The President led the audience pay a special tribute of standing ovation to the VP H.E. Mohamed Abdi aw Ali for the historic peace mission he has been undertaking in the eastern parts of the country for the past two months that has been greatly hailed for his pragmatism, given the precarious nature of the situation, hence is quite successful and on course.

He reiterated the state's resolve to sever the Somaliland-Somalia Talks given the latter's blatant violations of Somaliland's territorial integrity.

The President's State of the Nation Address is hereunder reproduced in its entirety, loosely translated from the Somali language: -

State of the Nation Address

Mr. Speaker, distinguished speakers of the two houses of the Somaliland Parliament, the Speaker of the Supreme Court, the heads of the national official parties, members of the cabinet, the commanders of the various national

forces, the Governor of Maroodijeeh Region, the Mayor of Hargeisa, leaders of the various sections of society, the women fraternity, youth, and all citizens of the Republic of Somaliland at home and abroad. Asalaam Aleykum;

With due respect to the august National Assemblies Parliament of the Republic of Somaliland, and at the same time in fulfilling the constitutional duty that instructs me to inform you of the general situation of the country, and the plan of the journey we are moving forward;

I begin by praying and remembering all the heroes who have fought for the Nation in the successive stages that have passed. Those who sacrificed their lives for independence, the successive leaders who served this nation, and the heroes who are now in uniform to consolidate peace, and protect the strength of the Nationhood we enjoy.

I reaffirm the obligation of the Nationhood of the Republic of Somaliland and that there is no negotiation on the unity, territorial integrity, nationhood of the Republic of Somaliland, the integrity of its history, traditions and culture of its people.

GENERAL SITUATION OF THE COUNTRY

Mr. Speaker;

Our nation is going through a particularly important stage; a stage where we must set the direction in which we will move into the future. We are emerging from a difficult environment resulting from the pressures of the economic downturn that has dragged on for the past three years, the weakening of national security and unity, the decline in our democracy, and the political stalemate that has led to the postponement of elections.

In the first hundred days of my government's tenure, it has taken important strategic steps to rebuild citizen trust, consolidate the foundations of peace, and implement the promised changes that the nation has placed its trust

Today, public safety and security are strengthening; the economy is stable and growing.

A broad reform of the judiciary and the administrative system of government institutions is underway, and public services and social affairs are expanding.

We have also infused new energy and vitality into our relations with the world and international cooperation.

More importantly, the ownership of the various sectors of the citizenry has been restored and they have been more involved in the leadership and decision-making of the country's future than ever before. Despite all this, we still face challenges that cannot be underestimated. A full economic recovery requires that we truly utilize our resources. Much work remains to be done to strengthen peace and

Defense and protection of the nation

Peace and security are the foundation of development and the shield of statehood. In the first hundred days, my government of "Togetherness and Action" has been able to implement important measures.

We nationalized the weapons and the civilian forces and began training them, which today have become a part of our national forces.

We conducted a census and a thorough registration of all our forces, in order to ensure the correct number of the various national forces, and to eliminate the name and existence of the word "Aagle" (ghost workers).

This is the key to the beginning of the large-scale salary increase that we are making for the forces. Today, the soldier receives his salary directly from the national treasury. The soldier and his family will receive free care and services. The government will improve the system of promotion and rewards for the forces.

We have benefited from new training for more than 700 officers. some of whom we have sent abroad for high-level training.

We have added modern technology and knowledge to the Immigration Department, and the Coast Guard, and have tripled their capacity to secure our maritime borders. We have also increased the level of security at all airports in the Republic of Somaliland.

To strengthen the national defense of the Republic of Somaliland, my government today announces the creation of the National Reserve Forces of the Republic of Somaliland.

5ØĐß. Good governance and Reform of the Judiciary:

Strengthening and improving the administration is the foundation on which good governance is built. Based on this vision, in order to strengthen the working capacity of government offices and the quality of services they provide, in the first hundred days we have reformed the work of government institutions and strengthened transparency and accountability.

The government has created or supplemented, revised and amended the laws that constitute the legal framework for transparency and the rule of law. Similarly, the policies and strategic plans that will form the basis for administrative reform and good governance have been completed. During this short period of time, the Government has implemented tax and revenue reforms, eliminating all loopholes that undermined good governance of government revenues in order to combat corruption. Government revenue in the three months from January to March has increased by 19%, compared to the previous two years. My Government is committed to strengthening the rule of law and ensuring that government leaders accountable for implementation of the law.

The Government has initiated a judicial reform plan to ensure fairness, independence and public confidence in the law and the judicial system of the country.

Infrastructural Development

During the short period of time that my Government has been in office, it has taken concrete steps that have been key to unlocking the economic potential of the Republic of Somaliland.

We have begun the construction and rehabilitation of key roads, which are the backbone of livestock and agricultural areas connecting domestic markets, cities and ports in the country.

Seven (/) key roads have been started, renovated or completed their construction studies. These include the key roads connecting Hargeisa/Balligubadle, Boorama/Baki.

We have also completed the assessment phase of the construction of the Lughaya port, which paves the way for us to make it a major commercial hub in the future.

The government has decided to reduce the electricity price in the city of Berbera to \$0.20 (twenty cents) per KW from July 2025, which will be the cheapest price in the cities of the Republic of Somaliland. The electricity network in the city of Zeila has also been Continue on page 4

First ever National Cultural Conference.....

Cultural Conference held at Mansoor Hotel.

The conference is the first Cultural Conference of its kind to be held in Somaliland, was organized with high esteem by the Ministry of Information, Culture and National Guidance, spear-headed by Minister Sheikh Ahmed-Yasin Sheikh Ali Ayaanle.

Somaliland Cultural Conference focuses on, and discusses, the lifestyle of Somaliland Society in general, especially issues of importance and priority for the people of the Republic of Somaliland in terms of culture, heritage, language, creativity, literature and fine arts. In particular, the National Cultural Conference focuses on nine topics: The Importance of Culture and Heritage,

The Head of State, who delivered a historic speech at the forum that touched on many aspects, described the symposiums as a very valuable one as per reflection on the cultural history that the nation and the people subscribe to vis-à-vis the modern times. He said that it would



provide a complete picture of the best way for the nation to develop in the future and benefit from our nobly rich culture.

The President, while speaking about the relationship between culture and the existence of society, said:

"Culture is the spirit of society. It is the foundation of lineage and the fabric of the nation. It is the thread that weaves us together from generation to generation, so that we do not fall apart. It is the guide of our values, our behavior and our religion."

While speaking about the originality of our rich culture, he said:

"Our culture is a native culture that has not been imported from abroad like some societies. It is a culture that reflects the history of our pastoral life, our Islamic faith, and the stories embedded in our heritages that reflect the thousands of years that we have inherited from our ancestors.

The President, while speaking about the dignity and unique qualities of our culture, said:

"Our culture is a culture known for its respect for dignity, good ethics, and profound knowledge, the vessel of which was our language, especially the poems that our ancestors preserved for us, which is one of the main reasons why the richness of our language has been preserved through the oral literature passed down from generations."

The President said that he expects "good resolutions from the Cultural Conference, so that it can be a starting point for the change that we, as a nation, will strengthen, protect, and express our culture, and prevent it from being lost to our future generations".

strengthened, which will have a direct impact on the lives of families in this coastal city.

The drilling of 32 wells, dams and ponds has been completed, to facilitate access to drinking water and irrigation for livestock and agriculture by citizens in arid areas, especially during droughts.

Economic Priorities for the Government

Based on these actions that have been possible in the short term, the Government's economic strategy focuses on three areas that we believe will increase domestic production - the country's GDP and the National Budget.

First focus: Production

Fisheries: We will complete the modernization and development of infrastructure, and technical knowledge in fisheries, and its marketing domestically and internationally.

Livestock: We will further strengthen the efforts initiated to develop livestock. To increase their health care and grazing, and to increase the export of live animals through foreign investments, and to process livestock products domestically.

Agriculture: In order for the Republic of Somaliland to become a country that produces enough food, we will strengthen the development of agriculture, especially irrigation systems, agricultural health care, light processing of food products, and to strengthen the domestic market for agricultural products.

The government, through its joint efforts, has secured foreign investment for two projects to modernize and improve agricultural production, funded by the Pharo Foundation with \$20 million and the German government with \$22

Minerals: Minerals are one of the major resources that we still have. The government's plan is to increase foreign investment and domestic investment to explore, produce and export them to world markets.

Taxation: Modernizing the tax collection system and broadening the tax base to finance the essential development of government services.

Entrepreneurship Investment: Enhancing entrepreneurship investment by citizens, especially youth and women

Berbera Port: We are committed to leveraging the expansion and modernization of the Berbera Port and improving the quality of services it provides to increase the number of areas outside the border served by the port.

The government continues to build and expand strategic roads, ports, and airports, so that we can share in the regional markets.

We will also strengthen natural energy, seeking investment in solar, wind, and hydrogen energy to provide affordable electricity to citizens, services, manufacturing, and industries. The World Bank is investing \$30 million in the cities of Berbera and Borama to finance solar power generation.

The problem of climate change is one of the most serious challenges crippling the economy. The Republic of Somaliland is among the countries that have suffered the devastating effects of climate change. We have set ourselves a special responsibility to care for the environment, control water and food shortages, and prevent the overall problems of climate change.

My Government's policy is to protect the environment, combat deforestation, and plant three (3) million trees during its term, which is equivalent to planting 600,000 trees per year. National Tree Planting Day in the Republic of Somaliland is celebrated on April 15th of each year, and we have launched a campaign to plant 300,000 trees in the middle of this month.

Social Affairs and Public Services:

We believe that it is imperative that citizens receive equal services from the government.

During the first hundred days, my government was able to accelerate public services. We have reactivated seventy-seven (77) health centers and hospitals, or have renovated and accelerated their services. This has increased the number of mothers who are delivered to health centers during childbirth, especially in areas far from health centers.

We have also begun to reform the country's education system. The steps taken include modernizing and developing the curriculum to include lessons that are useful for building society, including building national awareness among students, good morals and ethics, protecting the environment, and combating discrimination.

We have emphasized that we will develop plans to increase the number of girls enrolled in schools (education) and reduce the number of students who drop out of school. We have also begun developing a prison education curriculum to prevent the habit of committing crimes and to encourage prisoners to contribute to society and work upon release.

The government has been able to provide free education to the first batch of orphans of the various forces of the Republic of Somaliland.

On the other hand, we have begun labor and civil service reform, implementing a pension fund, and enhancing infrastructure that facilitates work, including

Turkey secures rights to 90 percent of oil and gas output in Somalia deal, document shows access to energy resources that Further enhancing its operational

Parliament for ratification on April 22. The release of the document has offered the first detailed insight into the scope, terms and strategic intentions behind Ankara's deepening energy and defense partnership with Mogadishu. Turkey has secured sweeping operational and financial privileges according to the agreement.

The document, officially titled "Agreement Between Government of the Republic of Türkiye and the Federal Government of the Federal Republic of Somalia in the Field of Hydrocarbons," was signed on March 7, 2024, in Istanbul by Turkish Energy Minister Alparslan Bayraktar and Somali Petroleum Minister Abdirizak Omar Mohamed. It was only recently made public as part of parliamentary proceedings. According to official justifications attached to the submission, the agreement is a key component of Turkey's Africa Opening Strategy, which identifies Somalia as a priority country due to its strategic maritime location and untapped energy resources. Somali territory is estimated to contain 6 billion cubic meters of proven natural gas reserves and as much as 30 billion barrels of offshore hydrocarbon potential.

Turkish authorities emphasize that with the improving political stability in Somalia, the country presents a viable environment for investment in hydrocarbons. The agreement, they argue, will enhance bilateral cooperation, allow Turkev to share technical expertise and secure

support Turkey's broader strategic interests in maritime trade and energy security.

The recently disclosed text of the hydrocarbon agreement has revealed a series of provisions that significantly favor Turkey's operational and financial position in Somalia's energy sector.

One of the most notable clauses removes the need for Turkey to pay any upfront costs. According to the agreement, no signature, development or production bonuses are required from Turkish entities, nor are they obligated to pay surface or administrative fees. These exemptions, outlined in the document's Article 4.5, deviate from standard industry practices where host governments typically demand substantial initial payments for exploration rights.

In terms of revenue structure, Turkey has secured a highly favorable cost recovery arrangement. Under Article 4.7, Turkey is entitled to recover up to 90 percent of the petroleum it produces each vear whether oil or natural gas — as "cost petroleum," a mechanism that allows the operator to cover exploration and production expenses before profits are shared. Meanwhile, Somalia's own share of the production is limited through a royalty cap set at just 5 percent. The royalties can be collected either in kind or in cash and do not apply to any petroleum that is reinjected into the reservoir or consumed during on-site operations.

freedom, Turkey has been granted unrestricted rights to export its share of oil and gas at international market prices. As detailed in Article 4.8, Turkish entities may retain all revenue earned abroad from the sale of these resources whether through exports or domestic transactions — an arrangement that effectively removes Somalia from the financial flow of Turkey's share. Additionally, Turkey enjoys broad discretion in assigning its rights under the agreement. Article 4.3 Turkish Petroleum Corporation (TPAO) or any other designated Turkish entity to transfer its interests to third parties without the obligation to establish a local company or permanent office in Somalia. This clause provides Turkey with flexibility in forming partnerships or bringing in without subcontractors bureaucratic hurdles.

The military school within the Turkish Task Force Command in Somalia (STGK), Turkey's largest military base abroad, also plays an important role in meeting the needs commissioned noncommissioned officers in Somalia.

Finally, the agreement includes robust investment protections. Article 9 confirms that Turkish operations in Somalia will be protected under the 1966 Convention on the Settlement of Investment Disputes (ICSID). Any disputes arising from the interpretation or implementation of the agreement can be brought
