Somaliland Council of Ministers Decides to Withdraw from the ongoing Talks with Somalia



Prime Minister of Somalia during his visit to Las Anood on April 12, 2025, which was a violation of international norms and the territorial sovereignty of the Republic of Somaliland.

The Government of the Republic of Somaliland, guided by its peace plan for the Eastern Sool Region, had previously announced a peace initiative on the day the President of Somaliland assumed office, December 12, 2024. It reaffirms that peace remains its top priority, while the defense of Somaliland's nationhood is an inviolable boundary.

Point 1: Somalia Has Completely Abandoned the Path of Peace and Dialogue

The Government of Somalia has openly strayed from the path of peaceful coexistence and dialogue, with the Prime Minister's visit to Las Anood being a deliberate violation of Somaliland's territorial sovereignty. This action was a political provocation and an

incitement to conflict, directly threatening the stability of the Horn of Africa, violating international laws, and undermining the freedom of Somaliland's citizens through unlawful abductions.

Point 2: No Negotiations Exist Regarding the Release of Prisoners

The Somaliland Government explicitly states that no negotiations have taken place with the Government of Somalia concerning the release of prisoners. The prisoners taken by Somalia's Prime Minister to Mogadishu are not prisoners of war. The Somaliland Government views this action as an attempt to mask the political failures of the Somali Government.

Point 3: International Cooperation on Prisoner Exchange and the Role of the ICRC

The Government of the Republic of Somaliland has engaged in discussions with the International Committee of the Red Cross (ICRC) and ambassadors of friendly nations

to resolve the prisoner issue, in accordance with international laws and procedures governing prisoners. Somaliland is prepared to engage in prisoner exchanges through any process consistent with international prisoner exchange protocols, under the auspices of the ICRC. The Somaliland Government has previously discussed prisoner-related matters with friendly nations, including the United States, the United Kingdom, Denmark, Turkey, and the United Arab Emirates.

Point 4: Somaliland's Appeal to the International Community

The Government of the Republic of Somaliland urgently calls on the international community to swiftly respond to the violations committed by the Somali Government in the Eastern Sool Region of Somaliland and to support Somaliland's efforts to restore peace in the region. Somalia's planned incursion into Somaliland threatens the stability of the Horn of Africa and creates opportunities for extremist and terrorist groups, posing a significant risk to peace and progress across the region.

Point 5: Termination of Talks Between Somaliland and Somalia

Given the Somali Government's repeated violations against the Republic of Somaliland territory and the principles underpinning previous dialogues between the two nations, the Somaliland Council of Ministers has decided to withdraw from the ongoing talks with Somalia, effective today, April 16, 2025. The Republic of Somaliland remains steadfast in defending its nationhood and upholding its sovereignty without compromise.

This visit reflects Somaliland's broader push for economic reform and international recognition, leveraging Islamic finance—a sector growing at 8.1% annually per the 2023 ICD-REFINITIV Islamic Finance Development Report—to strengthen its financial systems amidst regional challenges like the Berbera Economic Free Zone development.

The seized wooden ammunition containers are clearly labeled:

"MINISTRY OF DEFENSE ARMED FORCES - THE FEDERAL REPUBLIC OF SOMALIA, CONTRACT NO: 1/1/438/1/SOMALIA" — an explosive revelation pointing to the misuse of foreign-supplied military aid originally intended to combat terrorism in Somalia.

On April 18, the Somaliland Ministry of Defense issued a strong condemnation, accusing Mogadishu of sponsoring an unprovoked attack against pastoralist communities in Duurmadare.

The Ministry stated that the assault was orchestrated under the directive of Somalia's Prime Minister, following his politically charged visit to Las Anod.

Intelligence reports suggest the attack was part of a broader effort to stir unrest within Somaliland's traditionally stable borders.

"This aggression is not only a violation of Somaliland's sovereignty but a reckless provocation that undermines peace in the entire region," the Ministry stated. "At a time when we champion security and cooperation, Somalia is fueling instability through proxy militias."

While Somaliland has maintained peace and democratic governance for over three decades, Somalia remains entangled in conflict and extremist violence. Al-Shabaab, the al-Qaeda-affiliated terror group, continues to expand its territorial control and now reportedly threatens the outskirts of

Mogadishu itself. Observers argue that Mogadishu's diversion of military resources from anti-terror operations to political warfare is exacerbating insecurity across the region.

Regional analysts warn that this development could have serious repercussions for international military donors—particularly those who provide arms and funding to Somalia under counter-terrorism frameworks. The Somaliland Ministry has called on global stakeholders, including the United Nations, African Union, and key Western governments, to urgently investigate how Somali-labeled weapons reached insurgents operating outside of internationally accepted mandates.

"This isn't just a localized conflict," said one regional diplomat. "It reflects a disturbing trend where international aid is repurposed for internal political agendas, threatening broader regional security and humanitarian stability."

Somalia is grappling with internal collapse and the growing threat of extremist groups like Al-Shabaab, while Somaliland stands firm as a stable, independent nation committed to peace and regional security. Despite facing mounting pressure from Somalia-backed militias, Somaliland continues to demonstrate responsible leadership and military discipline. This moment presents a vital opportunity for the international community to recognize Somaliland's stability, support its sovereignty, and take decisive action to prevent further destabilization in the Horn of Africa.

Presidency Minister Updates House on Government Separation of Powers Law

he Minister of the Presidency of the Republic of Somaliland, Hon. Khadar Hussein Abdi, appeared before a session of the Somaliland House of Representatives, chaired by the Speaker, Yasin Mahmoud Hiir Faratoon. He provided an explanation regarding amendments and updates to the Law on the Separation of Powers of the

Government and Independent Institutions.

Minister Khadar Hussein Abdi, giving detailed insights to the Members of the Somaliland House of Representatives about the law on the separation of powers between the government and independent institutions, noted that this law defines the boundaries of governmental institutions.

Speaking on the matter, the Minister said, "It is an honor to stand before you to provide details and clarification on the law concerning the separation of powers of the government and independent institutions, which we have requested you to approve for amendments and updates. This law was enacted in 2015, and it serves as the foundation for the structure and definition of the powers, duties, and cooperation between the executive branches of the government, such as ministries and independent institutions."

The Minister of the Presidency of the Republic of Somaliland, Hon. Khadar Hussein Abdi, further added, "This law clarifies the hierarchy of powers among various institutions and their roles, which has played a significant role in strengthening good governance. However, as we understand, governance and administration in general are not static; they are dynamic processes that constantly evolve. Therefore, it is necessary for laws and policies to adapt to new needs."

National Intelligence Agency warns members of the public against spreading false news



In a press statement issued today, the agency issued a stern warning to the members of the public, stating that anyone found engaging in such acts will face legal action.

The statement reads as follows:

"In recent months, there has been an increase in individuals deliberately spreading baseless news and propaganda on social media platforms against the National Intelligence Agency. These actions mislead the members of the public of the Republic of Somaliland with false narratives far from the truth, aimed at undermining national security and creating distrust between the National Intelligence Agency and the people

of the Republic of Somaliland.

The National Intelligence Agency and all security institutions will identify those spreading false news on social media as individuals working for the enemies of the Republic of Somaliland."

The statement further warned the public, saying:

"We hereby issue a final warning to those involved in the aforementioned activities. The public is also advised to avoid spreading false news that targets the National Intelligence Agency and other security institutions. Anyone found engaging in such acts will face legal consequences in accordance with the law."

areas surrounding the East Sool region where clashes occurred.

A press statement signed by the Minister of Justice, Hon. Yonis Ahmed Yonis, stated:

The Somalia government has blatantly violated international laws, including regional (African) regulations, particularly the Third Geneva Convention (1949) concerning prisoners of war. Specifically, Articles 12 and 118 stipulate that the release of prisoners of war must not be used for political purposes or to exert pressure on any party. According to International Humanitarian Law, prisoners of war must be handled in accordance with international legal standards.

However, the Somalia government has used these prisoners for political purposes and to pressure the Republic of Somaliland, forcing them to wear the Somalia flag. Additionally, the prisoners have suffered from widespread neglect and lack of care.

There have been no direct negotiations between the Somaliland and Somalia



governments regarding the exchange of prisoners. However, the Somaliland government is engaging with the International Committee of the Red Cross (ICRC) to facilitate the transfer of these prisoners.

Consequently, we call on the Somalia government to hand over the prisoners, who were illegally abducted, to international organizations responsible for handling prisoner exchanges.

We also urge the international community and human rights organizations to closely monitor the situation of the prisoners transferred

from Eastern Sool's Lasanod and to pressure the Somalia government to cease its unlawful interference against the Republic of Somaliland.

We further call on the Somalia government to refrain from politicizing the prisoners detained in Eastern Sool's Lasanod, so as not to undermine efforts toward peace and prisoner exchanges.

Finally, the Republic of Somaliland reaffirms its commitment to establishing a mutual understanding in line with international laws for the exchange of prisoners.

The Minister of Foreign Affairs and International Cooperation of the Republic of Somaliland, Hon. This decision to suspend talks must mark a shift in priorities. Now is the time to focus on rebuilding a modern, capable military and ensuring economic resilience.

The threat of external aggression — whether political or military — is real. Preparation is not provocation. It is our right and our duty to defend our people and our territory.

Equally, economic independence must be front and center. We must invest in local industries, strengthen infrastructure, empower entrepreneurs, and fully leverage our ports and trade routes. These aren't lofty ambitions — they are critical to our national security and future.

A New Era of Global Engagement

President Cirro's recent presence at the World Government Summit in Dubai was a powerful signal of Somaliland's growing diplomatic reach. There, he positioned our nation as a stable, serious, and strategic partner — not only for Africa, but for the world.

Our relationship with the United States continues to deepen. From my position in Minnesota, I've seen bipartisan interest in Somaliland increase significantly. U.S. policymakers are recognizing our vital role in safeguarding Red Sea trade, countering extremism, and advancing democratic governance in the region.

We must harness this momentum. Recognition may take time — but it is inevitable, and we must be prepared when the moment arrives.





The Council of Elders (Guurti):

The Somaliland Guurti had come into being as the need of struggle against the Siyad Barre regime required by taking care of three important duties: Recruitment, Mobilization, and Fund-raising issues for the SNM armed wing (fighters). After the liberation of the country by SNM, both the nature and functions of the Guurti have changed. Immediately after the liberation, the Guurti started operating in the area of peace and reconciliation campaigns and continued leading the efforts for stabilization, and as the pillars of reconciliation, they remained as an indispensable factor. From these positions, they turned out to be the Council of Elders and then as the upper chamber of the Parliament. Unfortunately, this very important institution had not been reelected or reappointed and remained an unrepresented body till today. That is the reason why this lawmaker Council should not remain unrepresented but should be

VP inaugurates Burao Technical Institute

The Vice President of the Republic of Somaliland, His Excellency Mohamed Ali Aw Abdi, and his delegation, who are still on their mission to build peace, develop the country have arrived in Burao City, where they were warmly welcomed after almost a two-month long sojourn in the Sanaag region.

Upon his arrival in Burao on Thursday, he inaugurated the renovated Burao Technical Institute, and also inspected the various departments of the college.

The VP emphasized the value of vocational training for the development of society.

He said, "The Vocational Training School in Burao has special memories for me because when I was still in school, some of my classmates opted to join the polytechnic institution and were soon employed after completing their courses while we were still studying hence it underscores the great value of attaining skills".

He reiterated the government's commitment to bolster and fledge technical centers in the country noting that they were catalysts of development and progress within the society.

The VP who has been on a crucial trip to the eastern parts of the country to foster peace and integrate civilian militia into the mainstream armed forces, revealed that the efforts had gone well and is about to be completed soon.

He pointed out that the last of the lot to be absorbed would have its ceremonial function held in Burao.

State Burn Seized Alcohol and Expired Food

The Somaliland Police Force, specifically the Western Hargeisa Division, yesterday displayed seized expired food items, including sugar, rice, and alcoholic beverages, which were jointly burned by the Marodijeh Regional Court, the Prosecutor's Office, and the Western Division Command in Hargeisa.

The Commander of the Western Division of the Hargeisa Police, Muse Hassan Kahin, stated that they burnt 234 liters of alcohol and 62 bales of expired or spoiled goods. He added that those caught with the alcohol and expired food have been brought before the law.

The Commander further noted that the expired food and alcoholic beverages were intended for sale to the public, issuing a warning to individuals he accused of habitually trading in alcohol and expired food, both of which pose significant risks to public health and safety.

Commander Muse Hassan Kahin

emphasized that anyone attempting such acts to harm the community will not escape security forces, and those apprehended will face punishment commensurate with their crimes.

On the other hand, a court official stated that while some individuals involved in transporting the alcohol escaped after the police pursued them, only the alcoholic beverages were seized. However, those accused of handling the expired food are in custody and have been brought before the court. The seizure of the alcohol and expired food was successfully carried out at the Hargeisa Central Police Station and the Ahmed Dagah Police Station.

The official further explained that, based on their observations, the alcoholic beverages were initially a national concern, but the batch burned this time was different as it was expired alcohol. Regarding the seized sugar, it was collected from sugar spilled on the ground during unloading at the port.

legitimized by either public election or renomination by their communities.

2. The Civil Servant question:

One critical issue for the statebuilding process lies in the lack of clear Civil Servant policy. For example, on a global level, Civil Servant is the main pillar of the State in any country of the world, and based on the civil servant law, any person of the Civil Servant body remains in his post until his retirement. What is happening here in Somaliland is something contrary to the norms in use in the world, in relation to the place and role of the Civil Servants. Unfortunately, after every election, the new president starts to discharge almost all civil servants and substitutes them with supporters of the new president. This started to happen from the Silanyo government and continued with President Muse Bihi, continued with President Abdulahi Irro. However, since the State Bureaucracy (Deep State) is not only the state management but also is the memory of the state and government, here the non-politicized body of the state apparatus became a matter of necessity to exist. Through a nonpoliticized concept of the state bureaucracy, the state becomes a national ownership; it does not belong to one party, or one clan, or region, or a certain group of people. That is the reason why the civil servants should remain neutral and out of politics. It is well known and acceptable globally that without a well-experienced and depoliticized state bureaucracy, there is no state at all.

3. Somaliland Political Parties and the virus of I respectfully urge your leadership Clannism. to initiate serious reforms in these

In the Somali society, clannism in politics is a historical dilemma. It is a social phenomenon that holds back the process of state building. Therefore, the tribal nature of the Somaliland Political Parties is a matter of political pandemic and a historical disadvantage, and thus a stumbling-block to the deeds and endeavors of detribalization of the political parties and organizations. On the other hand, it is a matter of unavoidable historical reality, which emanates from the socio-economic

reality of the society. Tribalism or Clannism, even as a backward historical category, is not the problem, but the problem begins when the majority of the political elites lack a patriotic mind and adhere to tribalism, and lead political parties from positions of opportunism.

De-Tribalization of the Somaliland parties should come through a process of qualitative renovation from clan entities to national institutions. This needs to be understood, not as a matter of shortterm process, but a long and painstaking transformation of the society from clan-based to community-class based society. Because it is to deal with a crucial need for the evolutionary nature of society. The required goal is two things: 1) a highly educated, cultured and honest political elite as leaders of the Political parties' and 2) a party building program that can produce new generations of leadership. The current of corrupt political-illiterates prevalent on the Somali political arena will remain the source of reproduction of Clannism and Statelessness.

In Conclusion:

Mr. President, the challenges outlined above are not new — but they are urgent. The success of Somaliland's statehood project depends not only on what we have achieved, but on the reforms we are willing to implement. We need a credible Guurti, a professional civil service, and political parties built on political national ideology rather than clan identity — parties that transcend narrow clan interests and reflect the national vision.

I respectfully urge your leadership to initiate serious reforms in these three areas. Your legacy, and the future of our republic, will be defined by the courage to act in the national interest. The people of Somaliland are ready — now, more than ever — for a new chapter of inclusive, professional, and visionary governance.
