

The President of the Republic of Somaliland, His Excellency Abdirahman Mohamed Abdillahi Irro, accompanied by the Minister of Foreign Affairs and International Cooperation, Hon. Abdirahman Dahir Aden, received the resident Ambassador of the Republic of Ethiopia to Somaliland, H.E. Teshome Shunde Hamito, at his office in the Presidential Palace on Tuesday.

According to the Spokesman of the Presidency Mr. Hussein Adam Ige (Deyr), the meeting was of particular importance to both parties, and was aimed at further strengthening the

traditional relations between Somaliland and Ethiopia.

The President of the Republic of Somaliland and Ambassador Teshome discussed ways to enhance cooperation and collaboration on regional security issues and the exchange of information to prevent any threat to the stability of the two neighboring countries.

Both sides expressed their commitment to further strengthening diplomatic relations and maintaining mutually beneficial meetings.

In addition, they discussed the need to prioritize the facilitation and improvement of trade between the two countries, with a focus on improving customs procedures and increasing the use of the Port of Berbera.

Finally, the two sides also discussed working together on issues related to migration and mobility. The meeting ended with successful mutual agreement.

Government Orders Mandatory Registration for...... | Rep of Somaliland House of......

The directive, issued by Interior Minister Hon. Abdalle Mohamed Arab, requires all foreigners without valid residency permits to report to immigration offices between May 6 and May 26, 2025.

According to the official notice, the measure follows concerns about undocumented migrants living in Somaliland without legal status. Foreign nationals who register within the stipulated period will be granted temporary residency permits. A registration fee will be charged as part of the process.

Those wishing to remain in the country beyond the registration window must submit a formal request to the Immigration Department. Applicants will be required to meet specific conditions and pay the necessary fees. Foreigners who choose to leave the country voluntarily during this period are free to do so, and their departure will be officially recorded at the point of exit. However, individuals who fail to register by the deadline will no longer have the legal right to remain in Somaliland and may face legal consequences, including deportation. Immigration authorities have been directed to assist and facilitate the registration process.



The Ministry also confirmed that no deportations will take place during the registration period, except in cases involving criminal activity. This initiative follows a prior

communication from the ministry dated April 29, 2025, which addressed the status undocumented migrants in the country. The government says the registration drive is part of broader efforts to regulate immigration, enhance national security, and ensure that all residents are accounted for under the law. primarily driven by Somalia's interference in Somaliland's sovereignty and internal affairs. The motion, introduced by members of the House, has been referred to the House's legal advisor for review. The advisor will assess its compliance with legal and procedural standards before any further action is taken. Somaliland's accusations against Somalia include attempts to influence its internal governance, with particular concern over Somalia's support for militias in the eastern Sool region. Somaliland views these actions as part of a broader effort by Somalia to undermine its authority and hinder its pursuit of international recognition as an independent state. The situation escalated recently when Somaliland Armed Forces seized a large cache of weapons following a clash with militias in the eastern Sanaag region. The weapons, including wooden ammunition containers, were marked with Somalia's Ministry of Defense labeling, raising questions about the diversion of

counter-terrorism purposes to fuel the conflict in Somaliland. Further inflaming tensions, Somalia's Prime Minister visited Eastern Sool region in Somaliland, prompting condemnation from Hargeisa. Somaliland views this visit as a provocative act, challenging its sovereignty and territorial integrity. The motion, now under legal review, underscores Somaliland's ongoing efforts to assert its sovereignty. The international community is being urged to take note of Somalia's actions, which continue to destabilize the Horn of Africa. As the motion progresses, the outcome could play a pivotal role in shaping the Horn of Africa's future relations.

Somaliland, despite lacking formal international recognition, has maintained stability, governance, and peace in its territory. This motion serves as a clear message that Somaliland will not tolerate external interference in its affairs as it continues its path toward selfdetermination and sovereignty .-Horndiplomat

VP briefs cabinet on the successful pacification mission

The 19th Session of the Council of Ministers of the Republic of Somaliland, chaired by the President of the Republic of Somaliland, His Excellency Abdirahman Mohamed Abdillahi Irro, and accompanied by the Vice President His Excellency Mohamed Ali Aw Abdi, was held Wednesday at the Presidential Palace.

It is worth noting that the President of the Republic of Somaliland warmly welcomed the Vice President of the Somaliland Republic to the Presidential Palace earlier.

They then entered the Cabinet Conference Room together, where the Ministers received the Vice President with a standing ovation.

The director said that the mayor of the capital city of Hargeisa, Cllr. Abdikarim Ahmed Mooge, in coordination with the security branches, is committed to ensuring that Hargeisa remains a safe city at all times, and is among the safest capitals in the world.


The City of Peace Movement

International Cities of Peace is an association of citizens, governments and organizations who have by proclamation, resolution, or by citizen advocacy established their communities as official Cities of Peace. Every community has a legacy of peace, whether it is by a historical event or by a local peace heroes or groups who have contributed to their citizen's safety, prosperity and quality of life. No city is 100% a city of peace, rather all are on the path to "becoming" a more peaceful city. Establishing a community as a peace city recognizes past achievements, encourages current initiatives, and inspires future generations for practical peace building.

The Ideal of Cities of Peace

According to the only scholarly paper to date on Cities of Peace, "Idee und Geschichte der neuzeitlichen Friedensstadt," written by scholar Peter van den Dungen, the following are major categories for consideration as Cities of Peace. Though many Cities of Peace are now being established by resolution, proclamation, or by a community action campaign, this document shows that the City of Peace movement has deep roots. Published only in German, the following is a rough translation of Peter's typology.

1. Cities where a particular war has been successfully concluded (through a peace treaty). Such cities may or may not officially declare themselves, then or later, a City of Peace. It may be the city itself, or its inhabitants, who initiate this process. Examples: Münster, Osnabrück, Dayton.



- 2. Cities which are the seats of international institutions which are significant for the maintenance of world peace. The city authorities in The Hague have declared their city a City of Peace, justice etc., but in Geneva (so far) such a denomination has been bestowed by citizens groups (only). Examples: Geneva, Den Haag.
- 3. Cities where important peace prizes are awarded/places where peace is being celebrated and honoured. Oslo is really the main city in this category, with a long and famous tradition because of the Nobel peace prize. Examples: Oslo, Frankfurt/ M., Aachen.
- 4. Cities which, having been destroyed in war, have used this tragedy to dedicate themselves to work for peace, with the focus being on either
- warning against nuclear weapons
- reconciliation
- tolerance and multicultural living This is the largest category of peace cities. Examples: Hiroshima, Nagasaki, Osaka, Coventry, Gernika-Lumo, Ypern, Antwerpen.
- Cities which have rediscovered and now are reconnecting with historical impulses from the past, especially the remembrance of a prominent historical figure born in (or associated with) the city, and who was a great peace advocate. This is to do with the nature, and construction, of historical memory. Traditionally, war heroes are remembered, but slowly the notion of peace heroes is making headway, and cities are rediscovering their peace history and tradition.

- Examples: Rotterdam (Erasmus), Atlanta (Martin Luther King, Jr.).
 6. Cities where important peace institutions once existed, or which once hosted important peace conferences, and which are rediscovering their peace past, and now want to remember this and build on it (similar to 5). Example: Luzern.
- 7. Cities where important peace research or peace training institutions have been created (and which have not been significantly affected by wars or conflict). Examples: Stadtschlaining, Bradford.
- 8. Cities which have joined one or more important international peace organisations, and which are playing a significant role in them (these cities have not been significantly affected by wars or conflict). Example: Manchester.

 9. Cities of practical
- 9. Cities of practical peacemaking, in ethnically diverse and polarised environments. Examples: Le Chambon-sur-Lignon, Neve Shalom/Wahat Al-Salam, Philadelphia.
- 10. Cities which have given their name to important peace documents of one kind or another, but which up to now have not (yet) taken any initiative to build on this and become self-consciously a peace city (even though their name is associated with peace). Examples: Pugwash, Dartmouth, Göttingen, Talloires, Krefeld, Sevilla, Mohonk.

Please note that 'cities' occasionally also refers to villages, or more generally 'places'. Stadtschlaining (7), Neve-Shalom (9), or Pugwash (10) are villages.

called open market operation" (Open Market Sale). On under Wednesday, leadership of the Governor, deputy Governor, and the Director General, the central Bank has taken a decisive and a strategic step as part of its ongoing commitment to monetary and financial stability. Through this initiative, the Bank injected 1 million dollars into the market to reduce pressure on the foreign exchange rate and curb the rising value of foreign currencies. Leveraging its monetary policy authority, the Central Bank strategically monitors market movements to stabilize the exchange rate and prevent abrupt, unpredictable changes. The Central Bank urges all Somaliland citizens to have confidence in their currency—the Somaliland Shilling—and to

refrain from actions that could disrupt or destabilize the foreign exchange market. The Bank will persistently carry out these operations until the foreign exchange market achieves stability and security. An Open Market Operation (OMO) is a monetary policy tool used by central banks to regulate the money supply and stabilize financial markets, including the foreign exchange market. It involves the buying or selling of government securities (such as bonds or treasury bills) in the open market to influence the amount of money circulating in the economy.

By using OMO, the Somaliland Central Bank aims to create a stable and predictable foreign exchange market, encouraging trust in the Somaliland Shilling and fostering economic confidence.

2024 and the initial months of 2025. He stated that in 2024, the courts handled 26,716 cases, comprising 14,046 civil cases, 7,908 criminal cases, and 3,500 enforcement cases. Of these, 22,220 cases (83%) were resolved, while 4,514 cases (17%) remain ongoing. In comparison, in 2023, the courts received 25,510 cases, with 22,445 (88%) resolved and 3,080 (12%) pending, indicating a 5% decrease in case resolution between 2023 and 2024.

He highlighted efforts to enhance judicial staff capacity, noting that in 2024, 181 personnel benefited from educational scholarships (fully funded or 50% subsidized), while 500 others attended short-term training courses on legal and supplementary skills, including first aid, fire safety, administration, and management.

Chief Justice Adam Haji Ali also emphasized the completion of the Supreme Court Library, which will serve as a reading hub housing legal documents and books essential for judges and legal researchers addressing complex legal issues scientifically.

He noted that the courts handle thousands of citizens monthly,

addressing case filings, complaint management, and providing efficient legal services. Mobile courts play a critical role in extending legal services from district to Supreme Court levels across various regions.

He also highlighted infrastructure improvements, including extensive renovations in 2024 at courts in Sanaag, Togdheer, and Saaxil regions, expansions at the Awdal Regional Court, and the foundation laying for the Qol-u-jeed District Court.

The 2024 annual report included revenue generated from stamp duty offices at various courts, with the Chief justice noting that the judiciary is among the highest revenuegenerating institutions in this regard. Additionally, he discussed the significant role of Sulux (mediation) in resolving civil disputes amicably, emphasizing its alignment with Islamic principles and Somaliland's legal traditions. He noted that mediation is increasingly trusted by the public, particularly when evidence is scarce or time is limited. In conclusion, Chief Justice Adam Haji Ali addressed challenges facing the judiciary, which are

Training program enhances public events'.....

The Commander of the Somaliland Police Force, Brigadier General Abdirahman Abdillahi Hassan, alongside Hargeisa Mayor Mr. Abdikarim Ahmed Moge, officially concluded a four-day intensive training program designed to strengthen public event security. The session equipped 25 police officers with advanced skills in crowd control and threat mitigation. The training, focused on Public Event Security Management, aimed to enhance officers' capabilities in ensuring safe, orderly, and professionally managed largescale gatherings. This initiative aligns with Somaliland's broader strategy to minimize security risks during major public events.

The program was implemented with the full support of EUCAP and UNTMIS, which provided critical expertise in curriculum development and execution.

Call for Public Cooperation Ahead of May 18 National Day Celebrations

With Somaliland's National Day (May 18) approaching—a highly attended event marked by nationwide festivities—authorities are ramping up security measures,



particularly enhanced vehicle inspections across the city.

To ensure efficiency and safety, the following structured checkpoint procedures—based on training best practices—will be enforced:

Checkpoint Deployment & Roles

- Minimum of 8 officers per checkpoint, each with clearly defined responsibilities.
- Two dedicated inspection officers per team:
- Officer 1 conducts thorough searches of:
- Vehicle rear compartments.
- Areas under seats.
- Any concealed spaces where hazardous items could be stored.
- Officer 2 inspects the vehicle interior, including:
- Front and rear seats.
- Floor areas.

Officer Safety & Equipment
All inspecting officers must be

Protective gloves (to prevent injury from sharp or dangerous objects).Face masks (as a precaution

This structured approach underscores the Somaliland Police Force's dedication to safeguarding citizens through professional, well-coordinated, and intelligence-led security operations. By applying these protocols, authorities aim to deliver a secure and seamless National Day celebration for all attendees.

equipped with:

across common national nstitutions, including infrastructure limitations, though progress is made annually. He identified land disputes as a major issue, driven by urbanization and rising land values, particularly in Burco, Boorama, and Berbera. However, he noted a decline in land disputes in Hargeisa due to the implementation of a modernized land information system (GIS), which has reduced fraudulent transactions and ownership conflicts. He urged the local governments of Burco and Boorama to adopt similar systems for property registration and oversight.

The Chief Justice also addressed the challenge of low public satisfaction, where some individuals pursue baseless claims through all court levels, only to reject final rulings and spread misinformation. He cautioned the public and media against such behavior and encouraged seeking balanced information to uphold justice.

He expressed gratitude to judicial staff for their dedication despite limited resources, as well as to partners, law enforcement, and constitutional institutions for their cooperation in delivering justice.

As May marks 34 years since Somaliland reclaimed its independence, the youth in schools, supported by teachers and the Ministry of Education and Training, have amazed the public with their vibrant displays of national pride and their commemoration of May 18th.

Mobile Courts: Extend legal services from district to Supreme Court levels across regions.

Revenue Generation

Stamp duty offices at courts generated significant revenue, making the judiciary one of the highest revenue-generating institutions in Somaliland.

Mediation (Sulux)

Sulux plays a key role in amicably resolving civil disputes, aligning with Islamic principles and Somaliland's legal traditions.

Increasing public trust in mediation, especially in cases with limited evidence or time constraints.

Challenges

Infrastructure Limitations: Common across national institutions, though progress is made annually.

Land Disputes: Major issue in Burco, Boorama, and Berbera due

to urbanization and rising land values. Hargeisa saw a decline in disputes due to a modernized GIS-based land information system, reducing fraudulent transactions and ownership conflicts.

Recommendation: Burco and Boorama local governments should adopt similar systems.

Public Satisfaction: Low satisfaction due to baseless claims pursued through all court levels, with some rejecting rulings and spreading misinformation.





President hails realization of peace in El-Afweyn

He announces major projects to be initiated in the area

The President of the Republic of Somaliland, His Excellency Abdirahman Mohamed Abdillahi Irro has highly lauded and hailed the realization of peace in El Afweyn, in the district of the Sanaag region, and at the same time announced that two major projects will soon be initiated and implemented in order to cement the foundation for peace. He pointed out that the first one would be the immediate construction of a fully fledged technical institute.

He underscored the fact that the churning out of skilled personnel for the nation's labour market was a top priority of his administration.

According to the second project to be implemented in the district would soon be revealed by his deputy, H.E. Mohamed Abdi aw Ali.

The announcement by the Head of State was contained in an address to the nation following the completion of the main task the government embarked on as its top priority; thus the pacification mission of the brotherly clans of El-Afweyn who has had skirmishes pitting them against each other for the past decade resulting in civil strife and leaving fatal casualties in its wake.

The passionate speech of the President beamed live over the week reflected his joy as the nation sighed in relief following the historical peaceful accord that the VP and his delegation brokered in a concerted task that took almost three months.

Similarly in juxtaposition was the intricate and crucial task of disarmaments that successfully culminated in having thousands of local community militia being absorbed and interrogated in the national armed forces.

President Abdirahman Irro underscored the fact that the state would tangibly strengthen and bolster the security arms of the government such that they would be able to handle superbly any security breaches that may occur anywhere, anytime.

He noted that the nation of Somaliland had always their aspirations as their hope as concerns their convictional desires in charting their own future.

He congratulated the Vice President and his delegation on the success they achieved in bringing peace to the El Afweyn district, adding that the first plan of the government was to unite the people and end the long-running conflict in El Afweyn, adding that he instructed the delegation not to come until peace is achieved.

His address generally went as follows: –



"My joy for the peace to prevail in El-Afweyn is not only because as President I feel the constitutional obligation on me to seek to strengthen the security of my people.

"I am a citizen who is happy with the peace and brotherhood that has come about and ended the bloodshed that has been spilling for many years in the area.

"I applaud the understanding, compassion and kinship that the elders and the community have shown in the Ceel Afweyn area".

He continued, "The Prophet (PBUH) stated that pacification and reconciliation are better than prayer, fasting and charity.

"Achieving peace in El Afweyn was one of the top priorities of the 'Togetherness and Action' government, which is why, despite the many tasks and expectations of numerous issues at hand to be addressed, we started the first day with the efforts for establishing peace in El Afweyn and the nationalization of the civilian forces. "Due to the gravity of the task, we entrusted the Vice President, Ambassador Mohamed Ali Aw Abdi, to lead a delegation consisting of government officials and traditional leaders, with the aim that they had to see to it that the efforts were fruitfully completed before they returned.

"We are thankful to God that they lived up to the expectations and have thankfully completed the tasks".

The President decried the clannish and tribal tendencies that he attributed to them as the main cause of strife and retrogression in any society hence urged the populaces to shun.

He made it clear that once there was peaceful stability in any setting in the country, the state would easily fledge public services and development.

He thus announced the building of a technical institute in El Afweyn and said the VP would have the pleasure of revealing the second major project in the area that the government has earmarked. He expressed his elation at the triumph of the VP's pacification mission.

He said, "I would like to express my gratitude to the traditional leaders and elders who have been working for a long time in the peacemaking process. I would like to thank the brothers and sisters who made peace in El Afweyn possible at last, the youth, the women fraternity and intellectuals of the area. I congratulate them for starting a new page in the history of the Republic of Somaliland today.

"The entire nation has learned a lesson that brotherhood and the traditional lineage of Somaliland are great".

He further continued, "Brothers and sisters, let us move forward, let us join hands, we are not a clan but a nation, we have only one hope, we have only one will, we have only one future, may God strengthen the peace and unity of Somaliland, may God make it a nation of justice and lasting prosperity.

"I commend them for showing that they are fighting an enemy and not the people of Somaliland. They have shown that the people of Sool are their own people".

Finally, the President called on the people of Las Anod to resolve issues through dialogue as the world resolves its internal issues.

"We call for peace, dialogue and brotherhood to resolve the issue of Las Anod, and one thing is for sure; the true fact is that people of Somaliland are one country, with one interest, one people, and that they cannot do without each other, and as such aspire to resolve issues with civility as the world resolves intricate issues, hence, as a government, we are ready for peace through dialogue with patience, listening, or arbitration.
