Minister of Civil Aviation and Airport Development, Hon. Fu'ad Ahmed Nuh, briefed the President in detail on the progress of operations at Egal International Airport and the Ministry as a whole, as well as the improvements made to flight services and public facilities at the capital's airport.

During the tour, the President inspected the newly upgraded Flight Information Centre (FIC), now equipped with modern systems that enable full upper-airspace management and aircraft guidance for all flights using Somaliland's airspace corridors.

The President praised the Minister, Deputy Minister, Director-General and the entire Ministry staff for their tireless efforts to modernize the national aviation system, upgrade airports and raise the quality of flight services. He stressed that civil aviation is the backbone of national connectivity and Somaliland's reputation on the global stage.

President Abdirahman Irro declared that his administration accords the highest priority to safeguarding the sovereignty of Somaliland's airspace and building complete technical and administrative capacity so that Somaliland can formally and independently manage its own skies.

National Airspace Coordination Meeting

Immediately after the inspection of the airport facilities, the President chaired the Somaliland Airspace Management High-Level Coordination Meeting. The closeddoor session addressed critical issues of airspace governance, sovereignty, flight safety, the e-Visa question and the optimal framework upgrading air-traffic communication and international flight management.

The President had appointed a high-level national coordination committee meeting, chaired by the Minister of Civil Aviation and comprising the Ministers of Interior and National Security, the Presidency, Defense, and the President's Legal Adviser, to oversee policy, regulation and strategic advice on upper-airspace matters. Communiqué Issued

The meeting concluded with a strong National Declaration on Somaliland Airspace Sovereignty. Key articles include:

1. The Government of the Republic of Somaliland hereby notifies the international community that full sovereignty,

management and safety oversight of the airspace over its land, territorial waters and air belongs exclusively to Somaliland. Any use of this airspace requires prior authorization solely from the Somaliland Ministry of Civil Aviation, in strict accordance with national laws international conventions.

- The Republic Somaliland categorically rejects and declares null and void the recent "e-Visa" issued by Somalia. That document has no legal effect in Somaliland territory and cannot be used for entry.
- 3. Effective 10 November 2025, every aircraft operating in or overflying Somaliland airspace must obtain prior overflight clearance issued exclusively by the Somaliland Ministry of Civil Aviation.
- 4. Somaliland appeals to the international community, UN agencies, ICAO, IATA, global aviation authorities and all flight-service partners to recognize the grave danger posed to civil aviation by Somalia's unilateral actions that interfere with Somaliland's sovereign airspace management.

In closing the meeting, President Abdirahman Irro stated unequivocally, "Somaliland will never sit idle while others attempt to control or administer our skies. Airspace sovereignty is a national red line and the very emblem of our independence."

Airspace Sovereignty, Independence and Safety of Airspace.

It noted that:

The Government of the Republic of Somaliland reaffirms that it exclusively owns the airspace, land and sea within the borders of the Republic of Somaliland.

Permission to use Somaliland airspace can ONLY be obtained from the Ministry of Aviation and Airport Development of Somaliland, in full compliance with national and international aviation laws.

#### Rejection of Somalia's Illegal e-Visa

The Republic of Somaliland declares that the e-Visa recently introduced by Somalia has no validity whatsoever in Somaliland territory and cannot be used to enter Somaliland.

Somaliland operates its own independent immigration and travel

Somaliland's policy is OPEN: Visa on Arrival. Every traveler to Somaliland can obtain their visa immediately upon landing at Hargeisa Egal International Airport or Berbera International Airport.

### Regulation of All Flights in Somaliland Airspace

Effective 10 November 2025, every aircraft using Somaliland airspace must hold a valid overflight permit issued by the Somaliland Ministry of Aviation.

Any aircraft without Somaliland permission will be denied transit. Violators will face enforcement measures under both Somaliland and international aviation law.

The Government of Somaliland calls on: International aviation authorities (ICAO, IATA), the United Nations. Bilateral multilateral partners to wake up to the danger caused by Somalia's politicization of civil aviation and airspace management-turning it into a weapon against the Government and people of Somaliland. This threatens the safety of every commercial and passenger flight using Somali/ Somaliland airspace.

Somaliland demands the following immediate actions:



The people of Somaliland have warmly welcomed government's electricity price cut. For example, in the capital Hargeisa, where the current rate is 0.79 cents, it will drop to the new rate of 0.59 cents starting December 2025, as set by the government.

This step is part of the Ministry's broader effort to ensure the nation has cheap, reliable, and trustworthy electricity.



According to the new decision issued by the Minister of Energy and Minerals, Eng. Ahmed Jama Bare,

electricity prices in Somaliland cities will now be 0.59 cents per unit, while the city of Berbera will

enjoy an even lower rate of 0.20 cents per unit.

This new policy will take effect on December 1, 2025, and is part of the election campaign promises

Governor Hirsi urged youth to pursue halal livelihoods through honest work and business, emphasizing Somaliland's abundant legitimate opportunities.

Somaliland's main opposition leader calls on the UK, USA, and IC to end futile engagement and embrace interest-based recognition.

In a high-level diplomatic push, Mohamoud Hashi Abdi, Chairman of Somaliland's largest opposition party KAAH, urged Britain, the United States, and the international community to abandon decades of "futile, ideology-driven engagement" and adopt a pragmatic, interest-based pathway to Somaliland's recognition.

Speaking after a "fruitful and candid" Tuesday-morning meeting with Rt Hon Kim Johnson MP, co-chair of the All-Party Parliamentary Group (APPG) on Somaliland, Mr. Hashi delivered a five-point roadmap that resonated strongly in Westminster corridors.

Key Highlights from the Closed-Door Talks

The Cost of Isolation

"Thirty-four years of international limbo have starved Somaliland of investment, stalled infrastructure, and left our youth vulnerable to migration and extremism," Mr Hashi said. "This status quo is not neutral—it actively undermines Horn of Africa stability."

A Kosovo-Style ICJ Shortcut
The KAAH leader renewed calls
for an International Court of
Justice advisory opinion,
stressing that Somaliland never
legally united with Somalia in
1960. "The 2005 African Union
fact-finding mission already
confirmed our unique case. It's
time global jurists, not politicians,
settle the matter."

African Union "No Longer Fit for Purpose"

Mr. Hashi argued the AU has failed to implement its own 2005 Ezulwini recommendations. "Continental bodies are paralyzed by Somalia's veto. Recognition must now come from

capitals that value results over rhetoric."

Post-Brexit Britain Must Lead Challenging the UK to shed the "One Somalia" straitjacket imposed by the 1994 US State Department and reinforced by Hillary Clinton, he declared:

"Brexit promised an independent foreign policy. Recognizing Somaliland would be its first strategic dividend in the Red Sea Lane."

Great-Power Race at Berbera's Doorstep

Warning of expanding Chinese, Russian, and Gulf footprints along the Gulf of Aden, Mr. Hashi cautioned, "Somaliland remains proudly Western-leaning, but a weakening global order leaves us no eternal luxury of patience. Mutual interests—counter-piracy, counter-terrorism, critical-mineral supply chains—demand reciprocity today."

A Warm Nod to a Long-Standing Friend

Mr. Hashi placed Ms. Johnson "among the historic ranks of Somaliland's greatest champions—alongside Archibald Hamilton and Ethel Crowther". He thanked her for consistent, principled advocacy and invited her to lead a cross-party parliamentary delegation to Hargeisa in 2026.

"Somaliland is not begging for charity—we are offering partnership.

Recognize us not because we are perfect, but because we are profitable—for your security, your supply chains, and your conscience", underscored Mohamoud Hashi Abdi, KAAH Party Chairman

The meeting signals a new, assertive phase in Somaliland's diplomacy: less pleading, more deal-making. With a stable democracy, a booming port, and zero tolerance for Al-Shabaab, the Somaliland republic is pitching itself as the Horn's most reliable anchor.

based governance," said Prof. Cortes, highlighting Gibraltar's record of inclusive, evidence-driven policy.

Prof. John Cortes stands as one of Gibraltar's most distinguished public figures, a scientist-turned-statesman, whose career spans academia, ecology, and public service. Currently holding six ministerial portfolios Education, Environment, Sustainability, Climate Change, Heritage, Technical Services, and Transport he embodies the rare blend of technocratic expertise and political leadership.

An Oxford-trained ecologist, Prof. Cortes has spent decades promoting biodiversity, sustainability, and civic progress in Gibraltar. Before entering politics, he directed the Gibraltar Botanic Gardens, co-founded the Gibraltar Ornithological and Natural History Society, and became an influential voice for environmental advocacy. Since 2011, he has been at the helm of multiple ministries, helping transform Gibraltar's education system, green infrastructure, and climate policy.

In this Exclusive Interview with The Advocate Post, Prof. Cortes speaks with Editor in Chief, Abdul Rafay Afzal about his scientific roots, Gibraltar's educational vision, environmental diplomacy, heritage preservation, and what small states can teach the world about resilience and sustainable development.

In a wide-ranging conversation, Prof. Cortes reflects on his journey from ecology to politics, sharing how science equips governance with a foundation of evidence and ethics. He outlines Gibraltar's remarkable educational reforms building 10 of 14 schools and ensuring university scholarships for all qualifying students. He discusses his country's post-Brexit political landscape, the EU-Spain border agreement, and how sustainability and education shape Gibraltar's future.

He also underscores the role of cultural heritage as a bridge

between civilizations, emphasizing cooperation with regions such as Morocco and potential collaboration with Pakistan, Somaliland, Africa and beyond. Finally, he offers a message of purpose to youth worldwide: lead with knowledge, heart, and service to others.

Q. You began your career as a scientist and ecologist before entering politics. How did this background shape your vision as Gibraltar's Minister across such diverse sectors?

My background as a scientist profoundly shaped how I view governance. I trained in biology at Royal Holloway, University of London, and completed my doctorate at Oxford in ecology. After returning to Gibraltar, I initially worked in health administration but soon returned to my roots becoming Director of the Gibraltar Botanic Gardens, which I restored from abandonment into a recognized institution. For decades I led environmental advocacy through the Ornithological and Natural History Society, which I co-founded in 1976. Eventually, my frustration with the government's outdated environmental policies led me to politics. In 2011, I stood for election with the encouragement of family and friends and was elected, later taking charge of the Environment Ministry. A scientist in politics brings something unique: decisions guided by evidence, long-term vision, and responsibility to both people and planet. Q. As Minister for Education, how do you see education preparing young people in small states like Gibraltar to become global citizens?

Our education system follows the British model like GCSEs and A-Levels but we've invested heavily to adapt it to Gibraltar's needs. Since 2011, we've built or completely refurbished 10 out of 14 schools, with the rest underway.

We emphasize project-based learning, inclusivity, and specialneeds education. Every

Gibraltarian who secures a university place, typically in the UK, receives full government sponsorship tuition and living expenses. This ensures equality of opportunity and brings back skilled professionals. We're now expanding vocational training because not all talent is academic. Our investment in education is the foundation of Gibraltar's progress.

Q. Turning to the Horn of Africa, Somalia continues to face instability, while Somaliland has maintained relative peace and democratic governance. As several European countries such as Denmark and France have already engaged Somaliland in education and environmental sectors, do you believe Gibraltar could also engage Somaliland through non-diplomatic cooperation for example, in education, environment, climate adaptation, or heritage projects?

That's an excellent question. While formal foreign relations constitutionally rest with the United Kingdom, Gibraltar is very open to non-diplomatic and technical cooperation. We already collaborate through NGOs and civic partnerships for instance, with Morocco and Senegal and we mobilized aid when Morocco faced the recent earthquake. So yes, if Somaliland or any region in the Horn of Africa approached us with constructive proposals, we would certainly be willing to explore joint on environmental management, heritage preservation, sustainability, or educational initiatives and more.

We may be a small territory, but a big heart, even small states can often serve as role models. Gibraltar's strength lies in practical, science-based governance and community engagement. These values are universal they can be shared anywhere cooperation is built on mutual respect and benefit and we would contribute and assist however we can.

## How a Port Town in Africa.....

Report published by DP World Chief:

"When most investors look at frontier markets, they do so from a distance – placing small bets through funds managed by others.

At DP World, as a leading global logistics provider, our strategy tells a very different story: making long-term infrastructure investments over decades, and in ways that transform economies and shift patterns of trade.

In this way, we have connected small businesses in remote areas to global markets, transformed ports with modern infrastructure, and used overland routes to extend the benefits of trade.

It is some of my most interesting work, requiring effective partnerships, consistent teamwork, and deep expertise amid complexity – as well as vision and boldness.

I want to bring it to life by taking you to a fascinating place with a remarkable future: Berbera.

A port town with international potential

Located on the Horn of Africa's coastline, the Port of Berbera in Somaliland overlooks the Gulf of Aden, positioned as a vital junction for trade.

To the northwest are the Red Sea and the Suez Canal – the gateway to the Mediterranean.

To the east lie the ports of the Middle East, including our Jebel Ali hub in Dubai, and those across Asia, including India's vast port infrastructure and hubs across the Asia Pacific and China.

While to the south are African ports, set to play a growing role as south-south trade develops, and as the continent grows both exports and imports.

All will play to Somaliland's strengths: stability with consistent commitment to growth, a young and ambitious population, and economic prospects, including significant minerals potential.

However, what's most exciting for Berbera is its potential to serve not just Somaliland, but increasingly, Ethiopia – one of Africa's fastest-growing and largest economies, with a population of 135 million people that vastly exceeds Somaliland's six million.

Unlocking the landlocked

Ethiopia has no coastline and has been reliant on the Port of Djibouti, which handles around 90% of its trade.

This creates a significant opportunity for Berbera. Its overland route to Ethiopia is of similar length, and by offering an alternative with outstanding port efficiency, it can increase speed, resilience and capacity for Ethiopia and the Horn of Africa more broadly – especially as trade grows.

Our own findings indicate that Ethiopia will need access to multiple ports to support its rapid economic growth, with the Berbera Corridor being the obvious additional gateway.

We were therefore delighted in 2016 when the government awarded us

a 30-year concession to operate and upgrade the port, with an automatic 10-year extension if performance conditions are met. Within this agreement, we have committed to investing up to \$442 million to develop the port and create a special economic zone covering 1,200 hectares, with room for further expansion, as well as tax and customs policies to support manufacturing and develop Berbera as a regional hub.

To support local communities, we have also invested in areas including education, healthcare and water infrastructure.

Working with partners

Unsurprisingly, we were not alone in seeing Berbera's potential, and our role was just one of several concerted investments encouraged by Somaliland's government.

The Abu Dhabi Fund for Development and UK Aid, the development agencies of the UAE and UK governments, announced grants for redeveloping the road from Ethiopia to Berbera. British International Investment (BII), the UK government's development finance institution, invested alongside us in the port and special economic zone.

In addition, the United Nations Development Programme (UNDP) also played a significant role in improving governance in Berbera and the region more broadly.

A port transformed

Today, the town feels very different from when we started work in 2017 There is an optimism in the air and the bustle of trade, which always makes me smile. We have extended the total quay length from 650 meters to over a kilometre and installed cranes that can handle some of the largest vessels.

Annual capacity has risen fivefold to 500,000 containers a year, and while in 2017 it took four days to unload an 800-container ship, it now takes just 10 hours.

Berbera's thriving economy

The economic benefits have been substantial. We employ around 1,300 permanent staff at Berbera, with 98% local employment, plus another 2,000 to 3,000 in non-permanent roles

There are people at Berbera who have become so skilled in their field that we send them to locations elsewhere to advise.

Broader benefits are showing in the local economy. The UNDP recently reported that by 2024, Berbera's local government revenue had soared to \$14m from \$1.5m in 2012, allowing increased spending on schools, healthcare and other services.

Meanwhile, trade developments continue apace. Recently, we announced a new direct shipping route from Berbera to our Jebel Ali port in Dubai, one of the world's largest and a major international hub. It joins direct services to Mundra Port in India, Jeddah and King Abdullah in Saudi Arabia, and Salalah in Oman.

Principles for frontier markets

Of course, investments on this scale require a range of factors to come together, as well as an understanding of local considerations. We know this from our work in Somaliland, as well as in other African countries.

But I often find it helpful to return to the guiding principles that form the ethos of our business – shaping how we approach strategy and how we invest and contribute to where we operate. Here are three:

But I often find it useful to have some guiding principles. They help us assess opportunities, and guide us as developments unfold. Here are three:

Where others see problems, look for opportunities. It's remarkable how widely held perceptions blind people to opportunity. Somaliland is a good example. It has a small population and very real poverty. However, it defies outdated stereotypes and is on a positive trajectory in terms of economic growth.

Build ecosystems, not just ports. A port with a special economic zone and overland routes is far more valuable than a port alone - an approach we've used successfully in Dubai. Investing in broader infrastructure and using our network to drive trade can be especially effective in frontier markets. In Berbera, we worked with UAE companies to develop a cooking oil packaging plant in the special economic zone and an oil import terminal at the port. Berbera now exports oil to Ethiopia and Somalia, as well as serving the local market, while bulk oil imports have helped lower prices for consumers.

If you build it, they will come. This phrase captures a mindset that underpinned our success in Dubai, and our subsequent growth elsewhere. When making pioneering infrastructure investments, we primarily assess the potential rather than immediate demand and are willing and able to take a genuinely longterm view. This approach enables us to align with national economic priorities, stimulate demand over time, and view short-term disruptions in context. It's an approach that distinguishes us from other investors and has paid off repeatedly over time.

Primed for a bright future

I have written about Africa's potential, both to increase exports, including manufactured goods, and to grow imports that contribute to economic development, strengthen trade, and reflect rising prosperity.

Across the continent, we're investing for the long term – in ports, logistics, and partnerships that extend the benefits of trade. Berbera illustrates all these points, and as its momentum increases, the opportunities will only grow. END. ## Dr. Beileh: Somaliland Meets.....

Dr. Abdirahman Beileh, Somaliland's Presidential Economic Advisor, explicitly stated during his keynote speech at the Somaliland Investment Conference that Somaliland fully satisfies all 11 internationally recognized conditions required to attract global investment.

The two-day event, hosted at the Sarovar Premier Hotel in the capital Hargeisa, has drawn 80 investors from 23 countries, including key participants from the Horn of Africa. The 11 Essential Conditions for Global Investment:

1. Political Stability

## Somalia's E-Visa Imposition: A Step Backward.....

Somaliland represents yet another unnecessary escalation in an already strained relationship. This move does not promote peace, progress, or regional cooperation undermines them.

For years, Somaliland has stood firm as a beacon of stability, governance, and democratic values in the Horn of Africa. Despite lacking international recognition, Somaliland's achievements in maintaining peace, conducting free elections, and fostering development have earned it growing respect from the international community.

It is no coincidence that this E-Visa decree comes at a time when Somaliland's diplomatic outreach to the United States, Europe, and the UAE has gained new momentum. Rather than responding with engagement or constructive dialogue, Mogadishu has chosen to weaponize airspace and travel regulations, a tactic that only highlights the fragility of its institutions and its fear of Somaliland's success story.

## A Misguided and Counterproductive Decision

The imposition of E-Visas on people traveling to Somaliland by Somalia is not about security or policy modernization; it is a political reaction rooted in insecurity. This decision does nothing to improve the lives of ordinary Somalis on either side of the border. Instead, it hinders travel, trade, and family connections, hurting Somaliland diaspora businesses and ordinary citizens who depend on the free movement of goods and people.



Moreover, this action represents a clear violation of Somaliland's sovereign right to administer and control its own airspace, a right it has exercised responsibly for decades. Until the legal separation between Somaliland and Somalia is formally and legally resolved through international mechanisms, Somalia has no legitimate authority to unilaterally impose aviation or visa restrictions on Somaliland. Such actions only deepen mistrust and further complicate efforts toward peaceful coexistence.

As President Abdirahman Mohamed Abdillahi Irro rightly stated, "Somaliland is not an enemy of Somalia nor we hate Somali people, nor does it seek conflict with its brothers." Somaliland's vision is one of peaceful coexistence, economic development, and deeper engagement with the global community. The future belongs not to those who build walls, but to those who build bridges.

A Call for Strategic Thinking Rather than escalating tensions through bureaucratic obstacles, Somalia's leadership should embrace a new strategic mindset, one grounded in regional cooperation and shared prosperity. The Horn of Africa faces immense challenges: climate change, unemployment, insecurity, and migration. These issues demand coordination, not confrontation.

Somaliland, for its part, must continue to strengthen internal cohesion, institutional development, and national unity. Our greatest asset lies in our stability and our ability to solve disputes through dialogue and democratic processes.

At the same time, I fully support the Ministry of Civil Aviation and Air Transport of Somaliland in pursuing legal and diplomatic channels to challenge this unjustified E-Visa policy. Somaliland's response should remain principled, lawful, and rooted in international norms.

Moving Forward

Somaliland's success has never depended on recognition from Mogadishu, it has come from the hard work, resilience, and vision of its people. Let us not be distracted by provocations or short-sighted policies. Instead, let us continue investing in education, infrastructure, technology, and governance, because that is where our true strength lies.

The world is watching. And the message Somaliland must send is clear: we seek peace, progress, and partnership not provocation

## Macroeconomic Outlook

## GDP

In terms of Gross Domestic Product (GDP), Somaliland's real GDP has generally been on an **upward trend since 2012**. However, it has declined over the past two years due to **heightened inflation rates**. Despite this, nominal GDP has continued to increase. Projections indicate that **real GDP** will recover, reaching USD 2.5 billion by 2026.

Despite the numerous challenges, Somaliland's economy is demonstrating signs of recovery and growth, supported by the commitment of the new Government to reform and stability. The livestock export sector is operating smoothly, reinforcing an essential pillar of the national economy and government revenue. At the same time, Somaliland's relationships with international partners continue to strengthen, paving the way for increased development cooperation, trade, and investment.

## **Revenue - Country Level**

## What is Revenue

Revenue refers to all the resources available to a Government for providing goods and services. It depends on every citizens daily actions. It is collected through taxes, sales of goods and services, fees, fines, property income, and transfers such as donor grants or aid.

### Revenue is collected through:



Taxes on International Trade and Transactions: Import and Export Duties and cross border earning.



Good and Service Tax: Citizens buying goods or serivces.



Property Income: From Rental of Governments assets.



Income Tax: Citizens earning income.



Tax on International Trade and Transactions-imports, exports and other duties



Sales of Goods and Services: Revenue from public hospitals, schools, water, electricity, etc.



Fines and Penalities: Charges for breaking laws or regualtions.

Revenue allows the Government to ensure that citizens can live a good live and that no-one is left behind and everyone is cared for. The Government provides:















# Comprehensive plan to entrench strategic national peace policy in the offing

The nation is geared towards entrenching national strategic peace policy and integrating it, by linking efforts on peace projects, in order to attain a permanently harmonious setting in the nation.

This has been revealed during this week's meeting of the cabinet members in their 40th session. Also, disclosed is the fact that the recruitment of public servants is henceforth to be led by the Civil Service

The meeting was chaired by the President of the Republic of Somaliland, H.E. Abdirahman Mohamed Abdillahi Irro, who was flanked by his deputy the VP H.E. Mohamed Ali Aw Abdi, was held on Wednesday at the Somaliland Presidential Palace.

The agenda this week entailed the following 11 points:

## Civil Service Employment and

The Chairman of the Civil Service Commission Mr. Abdiaziz Hirsi Warsame briefed the Cabinet on the reform, administration and management of the Civil Service, detailing the process of verifying, securing and correcting the personal data of the civil service employees as per the HRMIS system.

The Chairman said that the said system has been fully tested, and the first phase of establishing, developing and implementing the Personnel Verification and Assurance System has been successfully completed.



He informed the cabinet members to prepare the personnel under their management to be at the designated place and time for verification of their personal

He likewise informed the Cabinet members of the Presidential Decree on the essence of the Civil Service Recruitment System, which will henceforth be led by the Civil Service Authority, in accordance with the Civil Service Law and related regulatory

3. Finance and Economy:

The Minister of State for Finance and Economic Development, Hon. Ismail Mawlid Abdilaahi, informed the House that, following the efforts made by the Ministry, revenue collection activities for January-October are proceeding as planned, with all the revenue projected for the 10 months having been collected as

The Minister emphasized that the Ministry of Finance is responsible for the collection of national revenue, as stipulated in the General Revenue and Taxes Law (Law No. 72/2016) and the Financial Management Law (Law No. 75/2016), hence that it is necessary that the revenues established by the law and collected by Government Agencies be directly deposited into the State Treasury; and that other revenues that are not legally established should be subject to legal verification.

He further noted that the Ministry has conducted studies and surveys to obtain data on the country's economy, as part of the Ministry's efforts to boost the national economy.

#### 4. Launching of DMSS at the Presidency.

The Minister of the Presidency Hon. Khadar Hussein Abdi, announced the launch of the Digital Media System Service (DMSS) in the Ministry of the Presidency, stating that the system was a modern process for unifying and improving the data, news and daily events that are necessary for the smooth flow of information sharing and communication among all government institutions.

The Minister of the Presidency, Hon. Khadar Hussein Abdi, observed that based on the impact of digital media on social life, it was thus necessary to coordinate, plan, analyze, and regularly share information among government agencies achieving a purpose of having a government with one aim and one voice. 5. Animal husbandry and drought

This was reported by the Minister of Livestock and Rural Development, Hon. Dr. Omar Shuayb Mohamed.

The Minister told the Council that the recurring droughts have greatly affected the health, population and production capacity of the country's livestock, especially in the eastern and Hawd periphery regions of Somaliland.

The Minister underlined that livestock are the backbone of the country's economy, but unfortunately climate change and droughts have had a negative impact on the lives of livestock. Their weight and reproduction rates have decreased, while malnutrition-related diseases have increased.

However, the Minister said that it is necessary for the Ministry and its collaborating agencies to implement a National Plan and applicable programs to address the increasing difficulties faced by livestock.

#### 6. Health:

The Minister of Health Development, Hon. Dr. Hussein Bashir Hirsi, briefed the Cabinet on the general health situation in the country.

Of note, he especially pointed out the three most reported diseases namely, diphtheria, measles and malaria.

The Minister detailed the measures taken by the health services such as awareness campaigns, vaccination, emergency treatment and expansion of health services at regional and district levels, to address the spread of these diseases and protect the general health of the community.

He also reported that the immunization campaigns to combat the major malaises afflicting children has kicked off across all regions in the country, with 533 teams, 2130 health workers,

It has projected to achieve vaccinations of 182,000 children.

He also informed his colleagues that the Ministry has made progress in using modern technologies such as the DHI2 HIV Tracker System and the EIR Tracker System (Electronic Immunization Registry).

#### 7. The Investment Conference:

The Minister of Investment and Industrial Development, Hon. Said Mohamed Burale gave the Council of Ministers a comprehensive report on the Somaliland Investment Summit which has just ended. He noted the major achievements, such as the interest shown by investors attending the Conference, the new MoUs and associated agreements signed, and the economic opportunities opened up for the nation, which will boost investment, job creation and economic growth in our

The Minister told the Council that the Somaliland Investment Conference has proven our country's readiness for real investment and international cooperation, as the government of Unity and Action has demonstrated its commitment to **Economic Development and Investment** Facilitation.

#### 8. Fisheries Development:

The Minister of Fisheries and Marine Resources, Hon. Ali Jama Farah, briefed the Council of Ministers on the general situation of Somaliland's fisheries, especially the ice-making facilities in coastal towns.

The Minister noted that they have activated several ice generation and refrigeration centers in the Sanaag and Awdal regions.

The Minister also gave a brief on a delegation from the Ministry of Fisheries of Yemen that visited Somaliland, and the cooperation measures agreed upon by the two countries. He said that bilateral discussions were led by the Deputy Minister of the Ministry, Hon. Sharmarke Abdi Musa.

#### 9. Planning: Peace projects and **National Peace Policy**

The Minister of the Ministry of Planning and National Development, Hon. Kaltuun Sh. Hassan Abdi, while giving the Council a comprehensive report on the most appropriate way to nationally link the efforts of Peace Projects and the National Policy on Peace issues.

The Minister highlighted the importance for the nation to have a system that unifies peace-making plans, development and the government's overall Agenda for the National Peace Policy and the unity of the Somaliland nation.

The Minister emphasized the goals of linking Peace Projects and the National Peace Policy of Somaliland being:

1. To prevent conflicts and violence.

- 2. To strengthen public trust and cooperation between the State and the people.
- 3. To create a system of justice that is equal for everyone.
- 4. To build institutions capable of resolving conflicts.
- 5. To promote education and peace awareness. 6. To strengthen peaceful relations with
- neighbouring countries and the international community.

#### 10. IDPs situation:

The Minister of the Ministry of Resettlement and Humanitarian Affairs Hon. Suleiman Duale briefed the Cabinet on the difficult situation of the displaced people in the country, noting that the drought has greatly affected their lives, especially their acc to water, food and adequate shelter.

The Minister said that the Ministry is making efforts to the best of its ability, including emergency assistance, to reduce the burden on the displaced community, but there is a need for a national consultation on this issue.

#### 11. National drought brief:

This was reported by the Minister of Religion and Endowments, Sheikh Abdullahi-Baashe Daahir Jama who is a member of the National Drought Emergency Committee.

He told the cabinet meeting that the drought situation is worsening, especially in the eastern regions of the country where there is a severe water shortage. The Minister said that the Drought Emergency Committee is planning to provide relief and assistance to the Somaliland community affected by the drought.
